The Grand Lodge of Kentucky shall hold its Annual Communication in Jefferson County on the third Monday in October each year, except that the Grand Master with consent of a majority of the Elected Grand Lodge Officers may change the place of Communication to some other County in Kentucky if they shall find it to the best interest of the Craft in the matter of publicity and hotel accommodations, or for any other reason or reasons which to such officers may appear sufficient; provided notice is given to the Craft prior to August 1st. either by mail or by publication in the Masonic Home Journal.

In case of a pandemic, war, natural disaster, or State of Emergency, the Grand Master with consent of a majority the Elected Grand Lodge Officers may change the date of the Annual Communication, location of the Annual Communication, and time for the election of Grand Lodge Officers if he finds it in the best interest of the craft.

LEGISLATION TO BE PRESENTED 222nd annual communication of the Grand Lodge of KY, F&AM

ITEM NO. 1

GRAND MASTER'S RECOMMENDATIONS TO BE ANNOUNCED

Resolution 6 (this will be the new Standing Resolution)

No Elected Grand Lodge Officer shall distribute any merchandise, souvenir, or other item bearing his name or programs prior to his election and installation as Grand Master, provided the sitting Grand Master may grant an exception to such distribution to incoming District Deputy Grand Masters, the Committee on Masons Helping Masons, the Committee on Veterans Affairs and Masonic Homes Ambassadors. Such exceptions shall only enable distribution of such items relevant to said Committee and officers in preparation for their respective terms at or following the annual District Deputy orientation, and further such items shall be distributed to no one else until after the installation of that Brother as Grand Master.

We the Committee on Jurisprudence have received the following proposed changes to "The Book of Constitution".

ITEM NO. 2

(Currently Reads)

ARTICLE 3 SECTION 2 - MEMBERS. (subsection 3) (3) An Elective Representative shall be chosen by ballot from the members of his lodge, to represent it in case its Master, Wardens, or Secretary cannot attend the communication of the Grand Lodge, and such representative shall be given a certificate of his election over the lodge seal.

ARTICLE 3, SECTION 2 - MEMBERS. (subsection 3) (3) An Elective Representative shall be chosen by ballot from the members of his lodge, to represent it in case its Maŝter, Wardens, or Secretary cannot attend the communication of the Grand Lodge, and such representative shall be *reported to the Grand Lodge Office of his election to represent his lodge at the Grand Communication*.

(Currently Reads) ARTICLE 10, SECTION 4 - REPRESENTATIVES, RECEIPTS IN FULL SHOWN.

Each representative shall exhibit to the Grand Treasurer the receipt of the Grand Secretary in full for all indebtedness of his lodge to the Grand Lodge before he shall be paid mileage or per diem.

ARTICLE 10, SECTION 4 – Reserved (Since these receipts are no longer issued for this purpose, and since each lodge is required to pay their indebtedness before they are officially registered for the Grand Communication, we The Jurisprudence Committee recommend the placing of this section in the reserved status for this purpose.)

ITEM NO. 4

(Currently Reads) ARTICLE 12- LODGE COMMUNICATIONS SECTION 1 -STATED COMMUNICATIONS.

The stated communications of the lodge shall be held at least monthly, at such place and time as may be specified in the Charter or Dispensation or authorized by the Grand Lodge and at such times as may be designated in its by-laws. If a Masonic burial coincides with the stated communication, the Lodge will follow the remains pursuant to Article 13, Section 1. Once the Masonic burial is completed, the brothers will return to the Lodge hall to continue the stated communication. Failure to hold stated communications, as provided in this section of the Constitution, shall authorize the Grand Master, at his discretion, to arrest the charter of the lodge or other action as he may deem appropriate. (2019)

Same as Currently Reads but with the following addition: ... to arrest the charter of the lodge or other action as he may deem appropriate. (2019) If the Local, State, or Federal authorities declares an unsafe travel condition or unsafe exposure to the members of a lodge, The Most Worshipful Grand Master and the Area Officer may call off, or cancel a Stated Meeting, If approved, The Craft must be notified prior to the meeting and the Secretary of the lodge must reflect in the lodge minutes for that date the reason why the meeting was called off or canceled and by whom the approval was granted.

LEGISLATION TO BE PRESENTED 222ND ANNUAL COMMUNICATION OF THE GRAND LODGE OF KY, F&AM

ITEM NO.5

(Currently Reads) ARTICLE 11 (B) ELECTIONS - LODGE OFFICERS SECTION 1 - ELECTIONS WHEN HELD.

Every subordinate chartered lodge is encouraged to elect its officers annually on St. John the Evangelist's Day, December 27, in accordance with Masonic Tradition.

Each lodge shall, in its By-Laws adopt an Annual Communication in December for the purpose of election of Officers.

(Proposed to Read)

Every subordinate chartered lodge, with the exception of Lodges of Research is encouraged to elect its officers annually on St. John the Evangelist's Day, December 27, in accordance with Masonic Tradition.

Each subordinate lodge, with the exception of Lodges of Research shall, in its By-Laws adopt an Annual Communication in December for the purpose of election of Officers.

ITEM NO.6

(Currently Reads) ARTICLE 17- DEGREES SECTION 6 - TIME BETWEEN DEGREES

The time between petition and initiation or affiliation and ballot thereon, and the time between each degree is a minimum of one lunar month, and the Grand Master is not authorized to dispense with this time, except in case or cases where it has been determined an Entered Apprentice and/or Fellow Craft Mason will not survive to be Raised a Master Mason under the aforementioned time constraint, the Grand Master is authorized to make the Entered Apprentice and/or Fellow Craft a Mason at Sight. (2009)

(Proposed to Read)

The time between petition and initiation or affiliation and ballot thereon, and the time between each degree is a minimum of one lunar month, with a maximum period of one calendar year. A one time extension of six months may be requested and permitted at the will of the lodge. If the Brother has not proven to be proficient in the preceding degree during said time, he will be suspended and be subject to reinstate-ment as set out in ARTICLE 27, (SECTION 4) of the Constitution. [Time limit will automatically freeze in regards to the Brother being in active military deployment, serious health issues, long term national emergencies or pandemics which interrupt lodges ability to meet.] and the Grand Master is not authorized to dispense with this time, except in case or cases where it has been determined an Entered Apprentice and/ or Fellow Craft Mason will not survive to be Raised a Master Mason under the aforementioned time constraint, the Grand Master is authorized to make the Entered Apprentice and/or Fellow Craft a Mason at Sight. (2009)

ITEM NO.7

(Proposed to Read) **ARTICLE 27 - RESTORATIONS** SECTION 4 (this will be a new addition to this article)

A brother suspended for failure to progress in the degrees within the time limit laid forth, shall rest under suspension until he has submitted a petition for reinstatement to the lodge from which he was first suspended, which petition must be referred to and be reported on by committee the same as any other petition for membership, and re-elected to membership by unanimous ballot of the membership present. Upon reinstatement the previous time limit, as laid forth in ARTICLE 17, (SECTION 6) shall restart.

ITEM NO.8

(Currently Reads) STANDING RESOLUTION NO. 4 - ELECTION OF DIREC-TORS

The Grand Lodge of Kentucky hereby advises and instructs that in the use of all Proxies, including Life Memberships owned by the Grand Lodge, relative to the election of Directors for the Masonic Homes of Kentucky, Inc., said Proxies shall be held jointly by the Grand Master, Deputy Grand Master, Grand Senior Warden, Grand Junior Warden, Grand Treasurer and Grand Secretary, and that a majority of the above Grand Officers, after due conference, shall have the authority to decide for whom said Proxies shall be voted. If any Elected Grand Lodge Officer shall be unable to attend the meeting called by the Grand Master, he may cast his vote by Proxy, provided such Proxy Vote shall be in writing, designating by name the persons for whom his Proxy Vote shall

be cast, and provided further that such written Proxy shall be delivered to the Grand Master at or prior to the Grand Lodge Officers meeting referred to above. In the event of a tie vote among the Grand Lodge Officers for a candidate, no Proxy of Life memberships held by the Grand Lodge shall be cast for that candidate.

APPENDIX A. Home Life Membership Certificates

The Masonic Widows and Orphans Home and Infirmary, was incorporated as a charitable institution by act of the Kentucky legislature on January 15, 1867. It has continued its corporate existence since that date although its Articles of Incorporation have been amended and restated from time to time.

The Old Masons' Home of Kentucky was incorporated as a charitable institution by the Commonwealth of Kentucky on October 25, 1901. Like the Masonic Widows and Orphans' home and Infirmary, it too has continued its corporate existence since that date, although its Articles of Incorporation have been amended and restated from time to time.

On February 12, 1993, the Masonic Widows and Orphans' Home and Infirmary and the Old Masons Home of Kentucky agreed on a plan of Merger, and on September 1, 1993 was incorporated by the Commonwealth of Kentucky as the Masonic Homes of Kentucky, Inc.

From its inception, the corporation has been controlled by its voting life members who elect the Board of Directors of the corporation. With the passage of time and the change in our tax laws, the corporation has further evolved into a public charity qualified under Section 501 (C) (3) of the Internal Revenue Code which qualifies contributions made to the Homes as tax deductible for federal and state income tax purposes. As a public charity, the operation of the Homes are subject to state and federal law and regulations.

The Masonic Homes of Kentucky, Inc., is a non-stock, non profit cor-poration. No part of the income of which can incur to the benefit of any member, director. or officer of the Homes or to any private individual organization or association not qualified under Sec. 501 (C) (3) of the Internal Revenue Code. Under dissolution, the assets and property of the Home must be conveyed or distributed to some other similar organization qualified under the same Internal Revenue Code section.

While Kentucky Masons as certificate holders elect the directors of the Homes, the Board of Directors has the legal authority and responsibility to oversee its affairs and operations. The corporation is a separate legal entity and subject to the internal revenue code and regulations enacted thereunder. This law requires that all funds, gifts, bequests, and devices must be used for the charitable purposes expressed in the Homes' corporate charter. No part of its income or property can inure to the benefit of any individual or for any non-charitable purposes including fraternal purposes. For this reason, the operations of the Homes are required to be conducted independently of the fraternity.

Admissions to the Homes and its policies and operations are determined by its Board of Directors through the power of the Board to adopt by-laws and make decisions at Board meetings for the government of the corporation.

Kentucky Masons may become life members of the corporation through the purchase of life membership certificates. Kentucky Lodges acquire Lodge Memberships through direct purchase. (2010)

Each Life or Lodge Membership certificate entitles the holder thereof to cast one vote per certificate in the election of directors to its Board. It is the process that has existed since the inception of the Homes that ensures that control over the corporation shall reside with the Master or other representative of such subordinate lodge of Kentucky at the annual meeting of the corporation.

When two or more lodges consolidate, the Lodge Membership certificate passes to the consolidated lodges.

In our Kentucky lodges we have three degrees; 3 principal officers; 3 knocks on the door; three steps to the Master's chair; 3 great lights; 3 lesser lights; Holy Bible, square and compass; sun, moon and master; wisdom, strength and beauty; brotherly love, relief and truth; 3 orders of architecture revered by Masons; 3 columns; 3 principal rungs on Jacob's ladder; 3 principal travelers; 3 times 3; 3 rough and tough workman; 3, 5, and 7 steps; and the earliest of triads used in Masonic ritual, 'Faith, Hope, and Charity'. I am sure you can think of more! Freemason Wolfgang Mozart used sets of three throughout his famous opera, <u>*The Magic Flute*</u>, believed to be a expression of Freemasonry. So why all the three's?

If we look into Masonic history, the same year as Anderson's Constitutions were printed, there appeared in "The Flying Post" (April. 1723) an anonymously written letter, and with it a Masonic exposure, later titled "A Masonic Examination – 1723". In a portion of the section of rhymed verse the Master states: "If a Master-Mason you would be, Observe you well the Rule of Three". Exposures cannot always be trusted, but in this case the rhymed section is followed by a series of questions and answers familiar to Masons of the early eighteenth century. So what then is the "rule of three"?

The "Graham Manuscript" of 1726, a very Christian Masonic manuscript and probably a copy of an earlier version, states in part, "while the two younger brothers of the fforesaid king alboyin disired for to be instructed by him his noble asiance by which he wrought to which he agreed conditionally they were not to discover it without a another to themselves to make a trible voice so they entered oath and he tought them the heorick and the practick part of masonry and they did work".

Even in this old English wording, every Royal Arch Mason will quickly recognize an 'oath' to communicate a Masonic secret only in the presence of a 'trible voice' or three persons. So here we have a Royal Arch Masonry practice, very soon after the forming of the first Grand Lodge and about the same time as the Master's degree is believed to have developed!

The 'Rule of Three' may also refer to three men who rule together. The Revd Neville Barker Cryer's book <u>York Mysterious</u> <u>Revealed</u> states that in operative masonry, three sat in the East and together they ruled over an operative lodge. This grouping is also found in many lodges when portraying the "Legend of the Temple". Every Royal Arch Chapter (York Rite) around the world reiterates the same practice of three in the East.

The virtues of faith, hope and charity were of important to operative masonry, and continues to be of considerable importance in masonic teachings today, "Faith, Hope and Charity; which admonishes us to have *faith* in GOD, *hope* in immortality, and



charity to all mankind. The greatest of these is Charity: for our *faith* may be lost in sight; *hope* ends in fruition; but *charity* extends beyond the grave, through the boundless realms of eternity". Obviously this is taken in part from 1st Corinthians 13:13 "And now abideth faith, hope, charity, these three; but the greatest of these is charity" (KJV).

'Three' is used extensively in the Holy Bible, a principle source for Freemasonry. The Christian Religion teaches the trinity of Father, Son and Holy Ghost; the three major Hindu Gods are Brahma, Vishnu and Siva - Creator, Sustenance and Destroyer; Amun, the Egyptian God also manifests as Ra and Ptah; and Greek mythology we have the God Zeus, with his Goddess Hera with their son Hercules.

In the Jewish tradition, the number 3 was considered as the perfect number, the number of harmony, wisdom and understanding. It was the number of the divine. Much of Mohammed's teachings and practices even today, are 'made perfect' in three's in Islamic tradition.

In everyday life we experience birth, life and death; youth manhood and age, past, present and future; beginning, middle and end. A salesman is taught to ask for an order three times to make a sale. A writer or a speaker should express an idea in three different ways, that his audience grasps his full meaning. Things are measured in length, breadth and thickness. We ourselves are representative of body, mind and spirit. We live in a 3-diminsional world. It is only natural to view things in three's.

So could the 'Rule of Three' in Freemasonry originally be 'Faith Hope and Charity', or a possibly a 'trible voice' or the even the 'three rulers' of an operative lodge, or just maybe, all three?What do you think?
