suspended members for non-payment of dues and other contributing factors deserves our serious attention in striving to be more successful with the reactivation process. Our membership unfortunately continues to decline. We must seriously look at every aspect of our fraternity to uncover the root causes of declining membership. There are three primary reasons for decreases in membership. They include death, lack of advancement from an Entered Apprentice to Master Mason and suspension for non-payment of dues. Death is a problem that we have no control. Lack of advancement must be addressed by having an effective mentoring program with proper orientation of the new Mason to our fraternity, providing opportunities for Masonic education and fellowship. I would like to focus on the area of suspended members for non-payment of dues that we as Master Masons must address and work toward the ultimate goal of prevention.

I wish to highlight the importance of developing or reinforcing an aggressive program that reactivates suspended members with your Lodge. Your Lodge has recently dealt with the issue of perhaps suspending members for non-payment of their dues in the month of June. You may ask yourself the question - What can be done to decreases our losses? I hope that you will concur with me that action should be taken in all Lodges to implement or revitalize a program to prevent suspensions.

First, it is important for us to examine our past statistics with your Lodge relating to this matter. The past and present should only serve to motivate us to do something about this severe problem. You may feel that the solutions we have tried in the past have not worked. However, we must consider the present and work toward achieving better results for our future by having a positive attitude. Secondly, the Worshipful Master should appoint a committee of three to five members to approach this problem with enthusiasm and interest in the suspended members. The committee members should prepare a list of names, addresses, and phone numbers of suspended members. A personal touch approach is highly recommended. A personal letter, phone call with a follow up visit to show your concern and interest in the suspended member can go a long way of renewing his interest in the fraternity. A letter conveying the interest of the Lodge to the suspended member of less than two years of suspension with the option to reinstate with active membership status based upon Section 187 of the Grand Lodge Constitution should be sent. Our Kentucky Constitution permits for a suspended member to be reinstated to active membership by the payment of sums due within a two year period. However, if a suspended member remains suspended for two years or longer, the individual can only be restored to good standing on payment of sums due and re-elected to membership by consent of three-fourths of the members present after receipt of regular petition. Our suspended members need to know the options available to them in reconsidering membership again with the Masonic fraternity. In your efforts, I urge you to be polite and tactful to find out the reasons of a member being suspended for non-payment of dues. A number of reasons could have caused his suspension due to a serious family hardship, lack of interest by feeling that he is no longer needed or wanted and the lack of Lodge programming with no activities for the family, the community or Masonic fellowship at meetings.

As officers and committee members of your Lodge, it is your charge of having enthusiasm and interest in the suspended member to persuade his reinstatement with the lodge. This process entails an awesome responsibility. By exhibiting enthusiasm for the Masonic fraternity, it can be contagious and usually everyone around you becomes enthused and excited.

It is essential to share with the suspended member the reasons he should remain a Masonic member. Several reasons include that he will be ineligible to continue as a member of other Masonic related organizations, no longer eligible to wear Masonic jewelry or emblems, unable to attend his or any other Masonic Lodge and hopefully point out the good things that your Lodge is doing for the members, the families and the community.

The Lodge officers should assess their current program and activities. Is the program relevant and meeting the needs of the members? A conscious effort should always be made to continue to attract and to retain the interest of our members. I am a proponent that programming precedes membership. Quality programming should be a primary issue as we concentrate on the following ingredients for successful operations: projects and activities that involve the entire family, a role with community involvement and visibility, productive, meaningful and interesting meetings with good Masonic education, quality time for Masonic fellowship and friendship at Lodge meetings and events and leadership opportunities for members to be involved with Lodge operations. Every member needs to feel valued, respected and appreciated.

Remember, every member that you prevent from going suspended is the same as obtaining a new member in regards to membership. It can be a very rewarding experience if you approach it with the right and positive attitude.

The benefits from an active program with this important initiative of reactivating suspended members can be many and varied. Let us explore the benefits that can be derived thorough a collaborative spirit of teamwork. We could realize by a substantial reduction in actual suspensions for nonpayment of dues the net loss in membership of our Grand Lodge may be substantially reduced. In addition, the losses to our individual lodges will also decrease yielding additional dues revenue.

Another benefit would be the possibility of revitalizing the interest in the Masonic Lodge and its programs on the part of many Brethren that have lost interest. Most members were once interested in the program of the Lodge and in Masonry. Perhaps many of them can be rejuvenated into active membership status again. This will lead to providing of additional opportunities for service to the Lodge and the Craft as a whole.

An enormous benefit would be valued information as to reasons why members are pursuing suspensions for non-payment of dues which would permit corrective action to be taken in that particular Lodge and even other recommendations that might eventually be adopted by the Grand Lodge to prevent suspensions in the future.



There are three very necessary and important sentinels posted at the entrance of every Masonic Lodge. The first (at the South Gate) is in the form of the recommendation of two members of the lodge petitioned, testifying as to the character and qualifications of the petitioner that they are proposing. The second (at the West Gate) is the Investigating Committee assigned by the Master to thoroughly investigate the character, reputation and qualifications of the petitioner, and of his willingness to conform to the rules of the order. The third sentinel (at the East Gate) is the membership of the lodge expressed by ballot. If these three sentinels are duty conscience and efficient, there is no way an unqualified petitioner should ever reach the door of the preparation room of any lodge. While each, in its own right, is of equal importance, the first priority falls on the first sentinel, since it is two signers of the petition who initially vouch for the integrity, character and reputation of the prospective member, and recommend him for the degrees. The second priority, of course, belongs to the Investigation Committee who must conduct an in-depth and unbiased investigation of the petitioner, and report accordingly to the lodge membership. The last priority, in due course, is the responsibility of the total lodge membership. The last priority is no less important than the other two simply because it is last in order. In fact, more responsibility should fall upon this sentinel because each member-should he have personal knowledge regarding the petitioner--would have his own assessment of the character and reputation of the petitioner, as well as the recommendations of the other two sentinels, in order to make his own personal judgement at the ballot box.

If these three sentinels are functioning properly, then it would seem to be impossible for any unworthy petitioner to ever enter the door of the preparation room of any of our lodges. It's only when one or more of these guards get lax in conscientiously investigating a petitioner that an unworthy candidate slips through, and, more often than not, brings dishonor and/or discredit to the Fraternity. To serve on the Investigating Committee is one of the most important assignments a member is called upon to perform. Should a petitioner's integrity, reputation and character not measure up to the standard for membership, it is much better for him to be rejected - hopefully at the South Gate - than he be admitted and bring dishonor to the Fraternity.

Many organizations - Masonic and otherwise are, at the present time, very concerned about declining membership numbers; and that is a reasonable concern, considering that a growing membership is a positive sign of the relevancy and interest of the organizations in the communities in which they are located. However, our forefathers have set a very high standard for those admitted into the Masonic Fraternity, and we hould be very careful not to compromise the integrity, honor and reputation of the Fraternity for the sake of numbers. By carefully following the procedures set out above, we have the best chance on not admitting an unworthy candidate, whom will have to be dealt with by the Masonic Code at a later time. Let's take great care to keep these three sentinels at their post!

office of members being suspended on other than a Stated Communication of the Lodge-- most always on the last day of June. Section 176 of The Book of Constitutions specifies that the suspension of a member is to occur at the stated communication set in the summons and the suspension is complete at that time.

The suspended member may become reinstated the next day in accordance with Section 187, merely upon payment of the amount owing up to the time he was suspended. However, that does not alter or erase the fact that the suspension occurred, and should be recorded as such.

Further, if the suspended member is a Plural Member, it is the primary responsibility of the suspending Lodge to notify the other Lodge(s) of which he is a member of the suspension in order for them to take appropriate action. As a followup the other Lodge(s) also receives a notice of the suspension from the Grand Lodge Office as soon as the information is received from the suspending Lodge.

Year-End Activity Reports

The office staff is gearing up at this time to verify the various lodge activities for the past year and to prepare the Annual Return information for each subordinate Lodge. With the exception of only a few Lodges, the Monthly Activity Reports have been received promptly in the Grand Lodge Office, insuring an accurate up-to-date account of each Lodge activity. I urge each Lodge Secretary to submit their monthly report in ample time to permit the assembling of the information for the Annual Report and presentation at the Annual Communication in October. The sooner we have the information the quicker we can prepare the Annual Return of your Lodge for verification.

It is not necessary to delay mailing the Annual Returns to the Grand Lodge Office until payment of the assessments is made. Once the Annual Returns are reviewed and verified, they should be mailed promptly to the Grand Lodge Office so the statistics can be prepared in ample time to complete the Advance Proceedings before the Annual Communication. The assessments payment may be submitted at a later date (prior to September 1, to avoid a penalty).

The Annual Returns were mailed from the Grand Secretary's office the last week in July and, as Secretary, you should have received them around August 1, 2006. Remember they must be received in the office of the Grand Secretary prior to the September 1, 2006 deadline. The payment for Grand Lodge assessments is also due at the same time. Late payment of the Grand Lodge assessments and/or the Annual Returns will cause a \$1.00 per day penalty to be assessed for each discrepancy until they are received in the Grand Lodge Office.


