

A question often comes to the Grand Lodge Office about how much lodge information should be kept by the lodge Secretary. Our answer has always been to keep as much as you possibly can. Obviously, the personal information on the lodge membership is of utmost importance, both for the present and for future reference, and should be retained indefinitely. Some lodge Secretaries even keep other information on lodge members in their personal file when they distinguish themselves in the community. The same goes for other records such as lodge minutes, deeds, correspondence, insurance contracts, tax information, bequests, IRS information, etc. The history of the lodge is maintained in the minute book of the lodge proceedings and the membership records of the lodge, and these items should be protected and stored in a safe, secure and fire-proof location. Some item,

such as cancelled checks, invoices, bank records, etc., may be destroyed when they are no longer useful. However, it is advisable to retain them as long as possible.

One basic item that should be preserved and filed properly is the original petition submitted for membership in the lodge, whether it is for the degrees or affiliation, and it should be filled out completely by the petitioner and the lodge Secretary. The importance of doing this was brought to my attention recently when a lodge member, trying to reconstruct the membership listing of his lodge for a new Secretary, called the Grand Lodge Office for information on the membership and records for his lodge. He could locate only a few items to assist him, and the information requested on the forms he did find was not complete, and consequently not of much use to him. Apparently, the previous Secretary did not think doing so was a high priority. The petition forms, if filled out completely by both the petitioner and lodge Secretary, contains all the basic information on the individual member, and should be retained for future reference in cases such as the one noted above.

As Secretaries, we are all too familiar with the loads of paperwork that we are required to deal with, and for the filing and maintenance of the same; however, maintaining such is worthy of our earnest efforts, and important for the preserving of the history of our lodges. So, be very conscious and selective in what you decide to discard.

AWARDS ELIGIBILITY LIST

Each Lodge Secretary should receive the "Award Eligibility List" from the Grand Lodge Office in May for those eligible for the 50, 60, and 75 year Grand Lodge Veteran's Awards. You will be sent instructions with your list that will explain specifically how to fill it out. Please follow these instructions precisely.

The plateaus in time that a Brother must reach to qualify for these awards are significant, and the Grand Lodge Office wants to insure that those Brothers due the award receive it timely. So, we encourage you to give this review your close attention.

COMMUNICATION BETWEEN LODGES

Just a reminder to each Lodge Secretary, if you are communicating with another Lodge within the Grand Jurisdiction of Kentucky in an official capacity, you may correspond directly with the said Lodge. However, any correspondence with a Lodge - or Grand Lodge - other than the one within whose Jurisdiction your Lodge is located must be transmitted through both Grand Lodge Offices.

This procedure is intended to insure that a complete record of the particular transaction is fully noted at each level. Following this policy also saves time in as much as Lodges, agreeable to Masonic Protocol, will not directly respond to correspondence from a Lodge outside their Jurisdiction - thus creating delays by stalling the correspondence.

Just remember, all out-of-state correspondence must be transmitted through the Grand Lodge Office.

GRAND LODGE BLANKET INSURANCE

By this time, each lodge Secretary should have received a Memorandum of Insurance statement from the Grand Lodge Office, showing the type, amount and a general description of the coverage each of the items in the agreement provides. You should file the same and use it as proof of coverage if, as you are most probably aware, insurance is a complicated business to most of us; consequently, it is well nigh impossible to prepare a general statement that would answer all the questions that may come to mind. However, if you find that you have specific questions concerning what is included in the coverage, and to what extent, you may call, either, this office, or contact:

The one insurance question we get most often in the Grand lodge Office concerns insurance on the lodge building. The blanket insurance carried by the Grand Lodge does not in any way include coverage on a lodge building, either liability or property. If your lodge owns a building, you must carry additional insurance to protect your membership. Should that be the case, you should contact a local insurance agency to determine the plan best suited for the needs of your lodge.

BATTLE OF RICHMOND MASONIC MEMORIAL

The dedication ceremony for the Battle of Richmond Masonic Memorial is scheduled for Saturday, May 10th, at the new Battle of Richmond Visitors and History Center, 101 Battlefield Memorial Highway in Richmond, Kentucky.

In 2006, the five Masonic Lodges in Madison County (Richmond #25, Madison (Kirksville) #183, Kingston #317, Waco #338, and Berea #615, along with the Richmond Chapter 3438, Order of the Eastern Star), joined efforts to erect the Battle of Richmond Masonic Memorial dedicated to the many Brothers of the Masonic fraternity who fought at the Battle of Richmond on August 29 & 30, 1862.

North and South, fought at the Battle of Richmond, making it the second largest battle in the Commonwealth of Kentucky.

Of the six generals that participated in the Battle of Richmond, three were known members of the Masonic fraternity. Federal Brig. Generals Mahlon Manson and Charles Cruft, both of Indiana, as well as Confederate Brig. General Patrick Cleburne, of Arkansas, all were members of the order.

The Battle of Richmond Masonic Memorial is the first monument on the battlefield at Richmond, and is believed to be one of the first of its kind in the United States honoring brothers who fought in the Civil War. The Grand Lodge of Pennsylvania erected the Friend to Friend Monument at Gettysburg in the 1990's.
