This memo was sent in September of 2007; however, we have received several calls recently regarding the same issue. Therefore we are reprinting the memo in the event that your lodge has received another mailing from the IRS.

**MEMORANDUM** LODGE SECRETARIES FROM: JOSEPH R. CONWAY SUBJECT: IRS LETTER

Your lodge MAY have recently received a letter from the IRS stating that you will have to electronically file your lodges return through them. This letter is a bit misleading. Under new law organizations with an income under \$25,000 will have to file an electronic card through the IRS website. However there are a few exemptions. Your lodge falls under one of the exemptions.

The letter we received states that the "exceptions to the e-Postcard filing requirement include organizations that are included in a group return; private foundations required to file Form 990-PF, Return of Private Foundation or Section 4947(a)(1) Trust Treated as a Private Foundation; and section 509(a)(3) supporting organizations required to file Form 990 or Form 990-EZ as described (in their letter). In addition, this filing requirement does not apply to churches, their integrated auxiliaries, and conventions or associations of churches".

We receive, from the IRS each year, a form to "group file" for the lodges who report their gross receipts for the year are under \$25,000; therefore the lodges of the Grand Lodge of Kentucky (who are under \$25,000) are exempt from any individual filing measures required by the Internal Revenue Service.

# Time Between Degrees.

The time between petition and initiation or affiliation and ballot thereon, and the time between each degree is a minimum of one lunar month, and the Grand Master is not authorized to dispense with this time. However, a Military Duty Waiver may be requested by a candidate/brother and granted by his home lodge.

# (1) Military Duty Waiver

A candidate, who has been accepted and duly elected to a lodge, or an Entered Apprentice or Fellowcraft, MAY request a waiver of dispensation on the time between degrees from said lodge, if he meets the following criteria. Approval of the request is left up to the DISCRETION AND SATISFACTION of the lodge. Proper documentation will be sent to the Grand Lodge for official record.

(a.) The candidate/brother is a member of the military.

- (b.) The candidate/brother has orders sending him to a known combat zone.
- (c.) The candidate/brother's date to report for military duty prohibits him from concluding his degrees in the usual allotted time period.

If candidate/brother does not meet all of the criteria listed above, the request MUST BE DENIED.

In which case, a six-month grace period shall be provided for the brother so elected to earn his Proficiency. In the event the Proficiency is not earned within the six month grace period, the Brother shall be deemed to have resigned his office and shall not be given credit for his tenure as a Warden. No brother shall be elected Master of a lodge unless he shall have proved his Proficiency in all three degrees and obtained a Grand Lodge Certificate of Proficiency. Nominees for Master shall have previously been installed as Master or as Warden of a lodge in Kentucky, except when no such brother who is so qualified and consents to act as Master shall be found among the members, and except at the formation of a new lodge.

# So as when Amended shall read: SECTION 82.

Qualifications. All lodge officers shall be Master Masons and members of the lodge of which they are officers. No brother shall be elected Master, Senior Warden, or Junior Warden of a lodge unless he shall have proved his Proficiency in all three degrees and obtained a Grand Lodge Certificate of Proficiency, except when no such brother who is so qualified and consents to act as Junior Warden or Senior Warden shall be found among the members. Nominees for Master shall have previously been installed as Master or as Warden of a lodge in Kentucky, except when no such brother who is so qualified and consents to act as Master shall be found among the members, and except at the formation of a new lodge.

#### **Business.**

All lodge business shall be done in a lodge of Master Masons, excepting proficiency examinations and approval and work of the first and second degrees or the trial Entered Apprentices or Fellow Crafts.

# So as when Amended shall read: SECTION 104.

#### **Business.**

All lodge business shall be done in a lodge of Entered Apprentice Masons, excepting proficiency examinations and approval and work of the second and third degrees or the trial of Fellow Crafts or Master Masons. Only Master Masons members in attendance can ballot on petitions or cast a vote for an election of officers. Additionally, no Entered Apprentice or Fellow Craft is eligible to any right or benefit exclusive to Master Masons. Lodges of research are exempt from this section.

#### **RATIONALE**

The purpose of this amendment is to permit Entered Apprentice Masons and Fellow Craft Masons to be involved in the routine affairs of the lodge.

This legislation will encourage Entered Apprentice Masons to begin attending Lodge regularly and begin the learning process at a faster pace than usual.

Entered Apprentice Masons anciently speaking, were permitted to attend Lodge so they may learn from their better informed Fellows, and Masters.

It is unjust to charge a good man dues in an organization to which he has no say, nor place. It could be deemed as taxation without representation Our founding Fathers knew too well about this issue.
