Vincennes Lodge No. 1 200th Anniversary Celebration



On March 13, 1809, Jonathon Taylor and six other Freemasons gathered in the city of Vincennes in the Indiana Territory and under the dispensation of the Grand Lodge of Kentucky opened Vincennes Lodge. Thus began Freemasonry in what was to become the state of Indiana, as well as the five states into which the Indiana Territory would be carved. On March 13, 2009, Masons from across the country will gather together again in Vincennes to celebrate the bicentennial of Vincennes Lodge No. 1, F & A.M.

With the creation of the state of Indiana in 1816, representatives from the six Lodges within the state met the

following year in Corydon to begin negotiations to form their own Grand Lodge. This was accomplished on January 13, 1818, at the Schofield House in Madison. And at that point, Vincennes Lodge No. 15 of Kentucky became Vincennes Lodge No. 1 under the Grand Lodge of Indiana.

"We are very proud of our past and our contributions to Indiana and Masonry," stated Johnny Edwards, Worshipful Master of Vincennes Lodge No. 1. "We hope that at our 200th Anniversary Celebration, we can honor both our past, as well as looking to our future."

It is unknown precisely where the Masons of Vincennes first met, and during the first 100 years of Vincennes Lodge, it moved about often through a succession of rented quarters. In 1915, a lot at the corner of 5th and Broadway Streets was purchased for the purpose of the construction of a Masonic Temple. A Temple Association was incorporated, sold stocks and bonds, and construction on the Vincennes Masonic Temple was begun. On November 2, 1917, Grand Master Elba L. Branigin dedicated the

LODGE DUES-DELINOUENT

A number of inquiries have been made to the Grand Lodge Office as to when a member is considered delinquent in the payment of dues and assessments to his Lodge(s). Section 154 of the Book of Constitutions of the Grand Lodge of Kentucky, F.& A.M., states that "The dues of all Lodges shall be due on January 1 each year, and payable in advance for the full year." Therefore, it would seem logical to conclude that a member who had not paid his dues and assessments for the current year would be considered delinquent on the first day of January of that year. There appears to be a discrepancy in the Section of the Book of Constitutions mentioned above since further on it states that "Dues for each year shall be delinquent on April 1, and the delinquent members shall be subject to suspension on the stated meeting of the Lodge in June."

However, in the latter instance the reference to the term "delinquent" applies to the point at which a Lodge may consider the suspension of a member-or members- for non-payment of dues and assessments. Please

keep in mind that the terms "delinquent" and "not in good standing" are not synonymous. A member is "delinquent" only until he is suspended for NPD-then he is considered not "in good standing". Section 154 referred to above merely sets the minimum time at which a member-or members- may be suspended for non-payment of dues- but does not set a limit on the time a Lodge may carry a member before suspension, if the Lodge chooses to do so. Further, a Lodge may, in the Lodge By-Laws; lengthen the time before the suspension of a member (i.e. after one year, two years, etc.)-but may not shorten the time. That is to say, a member owing only the current years dues cannot be suspended before June of the year the dues become payable.

Realizing that Lodge dues and assessments are necessary to provide the funds required to keep our Lodges, the Grand Lodge, and our Masonic charities financially sound and viable, the most prudent approach would be for each one of us to remit our dues to the Secretary of our respective Lodge immediately upon receipt of the dues notice, thereby, eliminating the necessity of the term

"delinquent" from our Masonic vocabulary.

NEWLY ELECTED SECRETARIES

Each year there are a number of new secretaries elected to that important office of the Lodge. The office of Secretary carries with it great responsibilities, second only to the Master, for the well being of the Lodge and it members. How well the Secretary responds to- and carries out his duties- is directly proportional to the success of a Lodge. An interested and knowledgeable Secretary is indispensable to the Master and his Lodge in moving our Fraternity forward, an uninterested Secretary will surly affect the Lodge in a negative manner.

So if you are a newly elected Secretary, my advice to you is; first, fully familiarize yourself with the duties of the office; second, make sure you communicate clearly and fully with the Master; and third, develop an unconscious and natural "feel" for your particular Lodge and each member therein. There are many responsibilities- but also many rewards if you can develop the right attitude. Welcome aboard and good luck!!

Vincennes Masonic Temple - home of the Masonic bodies located within Vincennes. It was constructed with special features including a pipe organ, an armory, a special room for conferring the Illustrious Order of the Red Cross, and the Catacombs. Projection booths were built into various rooms as well as means of communication between people conducting multiple candidates through various degrees. For the Middle Chamber Lecture, a special series of steps were built into the Lodge Room that could be hidden away when not in use.

Early members of the Lodge reads like a Who's Who of Indiana's early history

General Washington Johnston -Frequently served as Indiana Territory and State Representative, Speaker of the Indiana House, first man admitted to the bar in the Northwest Territory, Jurist Deputy Grand Master and instrumental in bringing Masonry to Indiana.

John Gibson - First secretary to the Indiana Territory, acting governor to the Territory, first to be made a Master Mason, and namesake of Gibson Country

Elihu Stout -First news paper publisher in the Indiana Territory, publisher to the territorial government, Grand Master in 1826 and credited with assisting in the preservation of Masonry in Indiana during the Morgan Affair.

William Prince - First Knox County sheriff (while in the Indiana Territory,) U.S Representative, captain at the Battle of Tippecanoe and namesake of the city of Princeton.




