# FROM YOUR GRAND SECRETARY

About six years ago some apparently disgruntled Freemasons decided traditional Freemasonry wasn't for them, and embarked on a quest to form a "United Grand Lodge of America of Accepted Free Masons". They vowed to change the face of Masonry in America. They prepared and distributed a "Masonic Declaration" establishing land-marks and so on. It appears the "UGLS" was formed by an expelled Mason and only attracted a small number to their ranks- most of whom probably were also expelled Masons. They rambled and ranted for a very short while to no effect and, apparently, have gone the way of irrelevance as have other clandestine groups, such as the Modern Rite of Memphis or the Rose Cross of Gold, etc, formed, supposedly, in the name and cause of Freemasonry. As with all such groups, the form, enjoy a brief breath of life, and then slowly fade away to oblivion.

However, just as surely as these groups pass away, others begin to form. Just a couple of days ago I received an e-mail attachment of a draft of a "Statement of Principles of The Foundation of Universal Freemasonry, Inc., supposedly "A Confederation of Independent Masonic Lodges" formed as a 501 (C) (3) non-profit Corporation in Wisconsin. The E-mail also included a "Declaration of the Masonic Peace Institute", whose directors, according to their web site, include members from the United States, Canada and a number of countries from around the world.

It does not appear either of these groups is recognized or endorsed by any Grand Jurisdiction with which the Grand Lodge of Kentucky is in amity, and should you receive any material and/or correspondence from the same, you should disregard it forthwith. 
