

#### GRAND MASTER'S **DECISION** CALLED COMMUNICATIONS


April 5, 2011

It has come to my attention there is some confusion among the Craft regarding an interpretation of Sections 107 and 108 of the Book of Constitutions as they apply to giving notice to members of Called Communications. First, I want to emphasize the importance of giving due notice to the membership of any and all Lodge Communications since the business of the Lodge is every members business and they should be afforded every opportunity to attend and take part if they

choose. Dates and times of Stated Communications are set in the Lodge By-Laws, and should be known to every member of the Lodge. Called Communications, however, require a special effort in order to assure every member of the Lodge is afforded that opportunity to be present and take part in the business of the Lodge. This is very important in order to maintain the peace and harmony in the Lodge. However, there are, apparently, some who feel a spontaneous Communication may be called without any notice to the membership. Being aware of this, and after carefully reviewing the aforementioned Sections, consulting the Committee on Jurisprudence and the elected Grand Lodge Officers, I feel it necessary to make this decision.

Therefore, it is my determination that due notice of all Called Communications must be given to the membership of the Lodge either "(1) In writing, addressed to the Lodge membership or member affected with postage thereon prepaid, (2) Published in the Masonic Home Journal, (3) Announced to the Craft by the Master or someone lawfully acting in his place during a stated communication of the lodge". The only exception is the calling of a communication for conducting a funeral service for a Brother because of the time constraint; however, even in this case, every effort should be made to notify as many Brethren as possible. The elected Grand Lodge Officers unanimously concurred with me in reaching this decision.



#### AWARDS ELIGIBILITY LIST

Each Lodge Secretary should have received the "Award Eligibility List" from the Grand Lodge Office in early April for those eligible for the 50, 60, and 75 year Grand Lodge Veteran's Awards. You will be sent instructions with your list that will explain specifically how to fill it out. Please follow these instructions precisely.

The plateaus in time that a Brother must reach to qualify for these awards are significant, and the Grand Lodge Office wants to insure that those Brothers due the award receive it timely. So, we encourage you to give this review your close attention.

#### **COMMUNICATION** BETWEEN LODGES

Just a reminder to each Lodge Secretary, if you are communicating with another Lodge within the Grand Jurisdiction of Kentucky in an official capacity, you may correspond directly with the said Lodge. However, any correspondence with a Lodge - or Grand Lodge - other than the one within whose Jurisdiction your Lodge is located must be transmitted through both Grand Lodge Of-

This procedure is intended to insure that a complete record of the particular transaction is fully noted at each level. Following this policy also saves time in as much as Lodges, agreeable to Masonic Protocol, will not directly respond to correspondence from a Lodge outside their Jurisdiction - thus creating delays by stalling the correspondence.

Just remember, all out-ofstate correspondence must be transmitted through the Grand Lodge Office.

#### GRAND LODGE BLANKET **INSURANCE**

By this time, each lodge Secretary should have received a Memorandum of Insurance statement from the Grand Lodge Office, showing the type, amount and a general description of the coverage each of the items in the agreement provides. You should file the same and use it as proof of coverage if, as you are most probably aware, insurance is a complicated business to most of us; consequently, it is well nigh impossible to prepare a general statement that would answer all the questions that may come to mind. However, if you find that you have specific questions concerning what is included in the coverage, and to what extent, you may call, either, this office, or contact;

The one insurance question we get 2011 are available from the Grand most often in the Grand lodge Of-

fice concerns insurance on the lodge building. The blanket insurance carried by the Grand Lodge does not in any way include coverage on a lodge building, either liability or property. If your lodge owns a building, you must carry additional insurance to protect your membership.

Should that be the case, you should contact a local insurance agency to determine the plan to suit the needs of your lodge.


