UAL COMMUNICATION PAMPHLET

The 213th Annual Communication pamphlet that contains instructions for the Lodge delegates who will attend the Annual Communication will be mailed to each Lodge Secretary on or soon after September 1. The pamphlet also lists all legislation that is to come before the assembly, along with the budget that is proposed for the next Grand Lodge fiscal year. Other budget information provided in the pamphlet is a projection of revenue that will be realized from the craft, based on the membership, and from other sources.

Each Lodge Secretary is instructed to read the pamphlet at the next communication of the Lodge following receipt of the same, and pass it on to the delegate that will represent the Lodge at the Annual Communication. This will insure that the delegates will come to Grand Lodge fully prepared to consider, discuss, and to act upon the issues at hand. However, should the delegate fail to receive one from the Secretary of his Lodge, one will be found in his registration packet when he registers at the annual session.

Every attempt is being made to ensure that each delegate is fully informed on the issues of legislation and budget prior to the Annual Communication. However, if some questions still remain, perhaps a call to the Grand Lodge Office or to one of the Grand Lodge Officers about your concerns might be helpful.

A reminder to all Grand Lodge Committee Chairmen who wish to have their reports printed in the Advance Proceedings, that they must be received in the Grand Lodge Office prior to September 15th. This deadline allows only enough time to assemble the Reports and complete the printing of the Advance Proceedings.

LEGISLATION TO BE PRESENTED AT THE 213th ANNUAL COMMUNICATION OF THE GRAND LODGE OF KENTUCKY, FREE AND ACCEPTED MASONS

ITEMS LAID OVER FROM THE 212th ANNUAL COMMUNICATION TO BE ACTED UPON

ITEM NO. 1

Amend Section 96. Brothers of Taylor Lodge No. 164, F&AM., Brothers of St. Andrews Lodge No. 18, F&A.M., and Brothers of Thomas Ware Lodge No. 340, F& M, wish to amend Section 96 of the Book of Constitution to read as: "to include Harrison County for concurrent jurisdiction". Submitted by:

St. Andrews Lodge No. 18, F.&A.M. Taylor Lodge No. 164, F.&A.M. Thomas Ware Lodge No. 340, F.&A.M.

ITEM NO. 2 SECTION 96.

In the cities having two or more lodges the jurisdiction shall be concurrent and extend as provided in Section 95, except, Adair, Alien, Anderson, Ballard, Barren, Bath, Bell, Boone, Bourbon, Boyd, Boyle, Breckenridge, Bullitt, Galloway, Campbell, Carter, Casey, Christian, Clark, Clay, Daviess, Estill, Fayette, Grant, Grayson, Green, Greenup, Hardin, Harlan, Henderson, Henry, Hopkins, Jackson, Jefferson, Jessamine, Johnson, Kenton, Knox, LaRue, Laurel, Lawrence, Lewis, Lincoln, Livingston, Logan, Madison, Martin, Marshall, McCracken, Mc-Creary, Mercer, Metcalfe, Monroe, Morgan, Nelson, Nicholas, Ohio, Oldham, Owen, Owlsey, Pendleton, Perry, Pike, Pulaski, Rowan, Russell, Shelby, Simpson, Taylor, Todd, Trigg, Wayne and Woodford counties, the jurisdiction shall be concurrent within said counties and extend as provided in Section 95. Boone, Grant and Kenton counties shall be regarded as one jurisdictional unit. (2010)

Be amended to include Lyon County thus reading: SECTION 96.

In the cities having two or more lodges the jurisdiction shall be concurrent and extend as provided in Section 95, except, Adair, Alien, Anderson, Ballard, Barren, Bath, Bell, Boone, Bourbon, Boyd, Boyle, Breckenridge, Bullitt, Galloway, Campbell, Carter, Casey, Christian, Clark, Clay, Daviess, Estill, Fayette, Grant, Grayson, Green, Greenup, Hardin, Harlan, Henderson, Henry, Hopkins, Jackson, Jefferson, Jessamine, Johnson, Kenton, Knox, LaRue, Laurel, Lawrence, Lewis, Lincoln, Livingston, Logan, Lyon, Madison, Martin, Marshall, McCracken, McCreary, Mercer, Metcalfe, Monroe, Morgan, Nelson, Nicholas, Ohio, Oldham, Owen, Owlsey, Pendleton, Perry, Pike, Pulaski, Rowan, Russell, Shelby, Simpson, Taylor, Todd, Trigg, Wayne and Woodford counties, the jurisdiction shall be concurrent within said counties and extend as provided in Section 95. Boone, Grant and Kenton counties shall be regarded as one jurisdictional unit. (2010)

ITEM NO. 3

Amend Section 176 & 177 of the Book of Constitutions which now reads:

SECTION 176 -NOTICE BEFORE ACTION.

No brother shall be suspended for nonpayment of dues until he shall have been notified by certified mail or personal service of the amount of his indebtedness, including the cost of such notice, and of the stated communication when the lodge will consider the question of his suspension for such non-payment, which notice shall be given not less than twenty-eight days next before the date of such hearing. The facts as to when and how such notice was given shall be entered in the minutes of the com¬munication when action in the case is taken. If the delinquent be suspended, notice of the suspension shall be delivered or mailed to the suspended member.

Be changed to read: SECTION 176 -NOTICE BEFORE ACTION.

No brother shall be suspended for nonpayment of dues until he shall have been notified by First Class mail or personal service of the amount of his indebtedness, including the cost of such notice, and of the stated communication when the lodge will consider the question of his suspension for such non-payment, which notice shall be given not less than twenty-eight days next before the date of such hearing. The facts as to when and how such notice was given shall be entered in the minutes of the communication when action in the case is taken. If the delinquent be suspended, notice of the suspension shall be delivered or mailed to the suspended member.

SECTION 177 -UNKNOWN ADDRESS.

When a brother's address is un-known and after every reasonable means to discover it shall have been exhausted, notice shall be given by certified letter sent to him at his last known address, in which case the steps taken shall be reported in open lodge, noted on record and read at two successive stated communications; after which the lodge may proceed as if notice had been received by the accused and he had failed to answer.

Be changed to read: SECTION 177 -UNKNOWN ADDRESS.

When a brother's address is un-known and after every reasonable means to discover it shall have been exhausted, notice shall be given by *First Class* letter sent to him at his last known address, in which case the steps taken shall be reported in open lodge, noted on record and read at two successive stated communications; after which the lodge may proceed as if notice had been received by the accused and he had failed to answer. ITEM NO. 4

Amend Section 187 of the Book of Constitutions which now reads: SECTION 187 -AFTER SUSPENSION FOR NON-PAYMENT.

A brother suspended for non-payment of dues shall rest under suspension-only until payment thereof shall be made. Payment of the amount owing up to the time he was suspended shall restore him to membership when the fact of payment is reported to, and noted in the minutes of the lodge; provided, if he shall remain suspended for two years or longer, he can be restored to good standing only on payment of said sums, and re elected to membership by consent of three fourths of the members present expressed by ballot after regular petition, which must be referred to and be reported on by committee the same as any other petition for membership.

So as when amended will read: SECTION 187 -AFTER SUSPENSION FOR NON-PAYMENT.

A brother suspended for non-payment of dues shall rest under suspension until <u>he</u> has submitted a petition for reinstatement to the lodge from which he was first <u>suspended</u>, which <u>petition</u> must be referred to and be reported on by committee the same as any other petition for membership, paid the amount owing up to the time of suspension, and re-elected to membership by unanimous ballot of the membership present.

ITEM NO. 5

Amend Section 107 of the Book of Constitutions which now reads: SECTION 107 -

CALLED COMMUNICATIONS.

The Master, or one lawfully acting in his place, may call a communication of his lodge at pleasure and upon written request of eight or more members of his lodge shall call a communication for the consideration of such matters as may be named in said request. Notice of all called communications shall be given to the members of the lodge: and no business shall be transacted at a called communication except that specified in the notice. Provided, that a lodge may be opened for instruction at any time.

So as when amended shall read: SECTION 107 -CALLED COMMUNICATIONS.

The Master, or one lawfully acting in his place, may call a communication of his lodge at pleasure and upon written request of eight or more members of his lodge shall call a communication for the consideration of such matters as may be named in said request. Notice of all called communications shall be given to the members of the lodge: and no business shall be transacted at a called communication except that specified in the notice. Provided, that a lodge may be opened for instruction <u>or the conducting of a Masonic Funeral Service</u> at any time.

ITEM NO. 6

Amend Section 108 of the Book of Constitutions which now reads:

Section 108-Notice. Notice to members of a subordinate lodge shall be (1) in writing addressed to the lodge membership or member affected with postage thereon pre-paid; (2) Published in the Masonic Home Journal; (3) Announced to the Craft by the master or someone lawfully acting in his place during a stated communication of the lodge. <u>Provided, that a</u> lodge may be opened for funerals, for the conference of degrees, or for the hearing of proficiencies in accordance with Masonic ritualistic tradition.

So as when amended shall read:

Section 108-Notice. Notice to members of a subordinate lodge shall be (1) in writing addressed to the lodge membership or member affected with postage thereon pre-paid; (2) Published in the Masonic Home Journal: (The Grand Secretary and the MH Journal is now Electronically transmitted to the lodges and to the membership as official notice, the same may apply to lodges with Electronic Email to it members, or mass phone communications, or Personal contact by committee or a designated member) or (3)Announced to the Craft by the master or someone lawfully acting in his place during a stated communication of the lodge. The Elected Grand Lodge Officers (Item will lay over as ammended by recommendation by the Committee on Jurisprudence. Ammendment shown in *italics*.)

ITEM NO. 7 Amend Section 154 of the Book of Constitutions which now reads:

SECTION 154. Dues to Fix and Collect. Each lodge shall fix and collect such annual dues as may be necessary to enable it to maintain itself and discharge its duties and obligations, payable before the Entered Apprentice Degree is conferred. The dues of all Lodges shall be due on January 1 each year, and payable in advance for the full year, except as provided by law as to Provisional Demits. Dues for each year shall be delinquent on April 1, and the delinquent members shall be subject to suspension on the stated meeting of the Lodge in June. Any lodge failing to collect dues from a brother, for more than one year, and failing to notify said brother of his delinquency each year, shall forfeit the right to collect more than one years delinquent dues from said member, and on payment of same, said member shall be in good standing with his Lodge.

SECTION 154. Dues to Fix and Collect. Each lodge shall fix and collect such annual dues as may be necessary to enable it to maintain itself and discharge its duties and obligations, payable before the Entered Apprentice Degree is conferred. The dues of all Lodges shall be due on January 1 each year, and payable in advance for the full year, except as provided by law as to Provisional Demits. Any lodge failing to collect dues from a brother, for more than one year, and failing to notify said brother of his delinquency each year, shall forfeit the right to collect more than one years delinquent dues from said member, and on payment of same, said member shall be in good standing with his Lodge.

ITEM 1

Amend Section 96.

Springfield Lodge No. 50, F&AM, Magnolia Lodge No. 201, F&AM, J. Speed Smith Lodge No. 298, F&AM, and Emulation Lodge No. 688, F&AM, respectfully request to have concurrent jurisdiction in Washington County, Kentucky.

ITEM 2

Where as there being no Established Protocol concerning Draping of the Charter due to the death or passing of a present or past Grand Lodge Officer, Joppa Lodge 167 voted unamiously at it's stated communication on June 5, 2012, to submit the following recommendation to the 213th Annual Communication of the Grand Lodge of KY. F&AM for consideration and adoption.

Recommendation as follows;

Having received information and conformation of the death and passing of any present or past GRAND MASTER or GRAND LODGE ELECTED OFFICER, that all subordinate Lodges in the jurisdiction of the Grand Lodge of KY. WILL Drape Their Charter and it will remain draped for one calendar month.

Please Note

This recommendation was inspired by the death of Most Worshipful Past Grand Master Kenneth Lawson and could be referred to as the Kenneth Woodrow Lawson recommendation if appropriate.

ITEM 3

9. Veteran's Emblems

Any Master Mason who shall have been affiliated with a lodge or lodges in Kentucky, or some other lodge with which Kentucky sustains fraternal relations, for a period of 25 and 40 years shall be entitled to wear a Kentucky Veteran's Emblem which may be purchased by the Lodge from the Grand Lodge of Kentucky. Provided, however, that said Master Mason be at the time a member in good standing of a Kentucky Lodge and any period of suspension or non-affilation must be deducted from the entire period since his initiation.

Any Master Mason who shall have been affiliated with a lodge or lodges in Kentucky, or with some other lodge with which Kentucky sustains fraternal relation, for a period of 50, 60, and 75 years, shall receive from Grand Lodge of Kentucky a Veteran's Emblem as approved for said purpose, as a reward of merit for his long and faithful service to the fraternity. Provided, however, that said Master Mason be at the time a member in good standing of a Kentucky Lodge and any period of suspension or non-affiliation must be deducted from the entire period since his initiation.

Change Paragraph 2 to read as follows:

Any Master Mason who shall have been affiliated with a lodge or lodges in Kentucky, or with some other lodge with which Kentucky sustains fraternal relation, for a period of 50, 60, and **each 5 years thereafter**, shall receive from Grand Lodge of Kentucky a Veteran's Emblem as approved for said purpose, as a reward of merit for his long and faithful service to the fraternity. Provided, however, that said Master Mason be at the time a member in good standing of a Kentucky Lodge and any period of suspension or non-affiliation must be deducted from the entire period since his initiation.

We believe all Brothers in this Grand jurisdiction should take the same obligations to each other, pass the same proficiencies, and receive the same lectures.

If the *Ky Rtl* is adopted, a second book will still be needed which includes the Installation Ceremonies, Funeral Services, lectures omitted from the *Ky Rtl*, Tyler's oath, and other necessary information.

This will also standardize the lectures required for the Bluegrass Ritualist Program.




