Junction. This meeting, for the most part, is truly about fellowship and brotherly love. What other meeting would you find your Grand Master in Bib overalls frying eggs? There is a time and place for everything, and I know we need to make the best of impressions when we are performing rituals and ceremonies, but we also need to make a special time when we can just be brothers with nothing more than enjoying each other's company and breaking bread together. This is a time of bonding and a time to laugh; the pressure of dress codes and titles are not needed and we are just brothers all on the same level.

On September 19, 1794, George Washington became the only sitting U.S. president to personally lead troops in the field when he led the militia on a nearly month-long march west over the Allegheny Mountains to the town of Bedford. Brother Washington's example should encourage all leaders to remain engaged in active service and to provide those who are called to follow them an example of true servant leadership.

Among the many established traditions that we as Kentucky Freemason have embraced is to honor our members who have reached the significate milestone of 50 years of service by no longer requiring them to pay membership dues. They have for decades been termed "Free-Masons." These dedicated men have spent the largest part of their adult life contributing to our lodges and our grand lodge with the belief that that promise will be fulfilled. It is my belief that despite whatever rationale a lodge would use to choose to renege on this promise, whatever gray area they chose to exploit, one basic truth is clear; they have broken established traditions that as Past Masters we promised to uphold when we were installed. One of the gravest realities of this, is when a 50+ year member is suspended for non-payment of dues. We are then prevented from affording him what I believe is the basic right of a Mason, a Masonic burial. Consider this, a member reaching the milestone of 50 years of service does not incur the local lodge any expense in the form of Grand Lodge assessment and in all likelihood very little, if any, expense to his lodge at all. We need to rethink this and quickly! As of this past July there are now 10 "Free-Masons" who, if they passed away today, would not be afforded a Masonic Burial. My Brothers, what have we become?

On a more celebratory note, I had the honor of presenting M.W. Brother Carol Curtis, PGM with his 70-year service pin, during a ceremony held in his honor on August 15; this was one of the highlights of my Masonic career. The turnout was remarkable! It is a testament to M.W. Brother Curtis' dedication, service, and love for the Craft that so many attended to celebrate this significant milestone with him. Brother Curtis is our Senior Past Grand Master having served as Grand Master in 1969-1970 and continuing to serve our fraternity in many ways. M.W. Brother Curtis still actively travels to present educational material about our ritual, takes an active part with degree teams presenting the Legend of the Temple, and always makes time to have discussions with his brothers, who are as ready receive as he is to give instruction. What an example to emulate!

As always, "We are our Brother's Keeper" and remember our active-duty military and first responders in your thoughts and prayers.

The Following contains in **BOLD** to be deleted. In **BOLD ITALIC**, the new wording. All else the same.

ITEM NO. 1

Consideration No. 1 (A, B, C) need to be grouped together due to their passage affecting each other.)

AMEND ARTICLE 11(D) SECTIONS 1-7, ARTICLE 14 SECTION 1, ARTICLE 28 SECTION 2,

The following changes are proposed as a package with Article 11(D) Sections 1-7, Article 14 Section 1, being amended.

Consideration No. 1 (A)

(Currently Reads)

ARTICLE 11 (D) JURISDICTION SECTION 1- GENERAL RULE. Section 95

The jurisdiction of every lodge, except as in ARTICLE 11 (SECTION- D) (2, 3), shall extend halfway to the nearest lodge meeting location by a straight line measurement in any and every direction.

SECTION 2- CITIES HAVING TWO OR MORE LODGES, Section 96

In the cities having two or more lodges the jurisdiction shall be concurrent and extend as provided in ARTICLE 11 (SECTION- D)(1), except, Adair, Allen, Anderson, Ballard, Barren, Bath, Bell, Boone, Bourbon, Boyd, Boyle, Breckinridge, Bullitt, Butler, Calloway, Campbell, Carter, Casey, Christian, Clark, Clay, Daviess, Estill, Fayette, Floyd, Grant, Grayson, Green, Greenup, Hardin, Harlan, Harrison, Hart, Henderson, Henry, Hopkins, Jackson, Jefferson, Jessamine, Johnson, Kenton, Knox, LaRue, Laurel, Lawrence, Lewis, Lincoln, Livingston, Logan, Lyon, Madison, Marion, Martin, Marshall, McCracken, McCreary, Mercer, Metcalfe, Monroe, Morgan, Nelson, Nicholas, Ohio, Oldham, Owen, Owsley, Pendleton, Perry, Pike, Pulaski, Rowan, Russell, Shelby, Simpson, Taylor, Todd, Trigg, Washington, Wayne, Webster, Wolfe and Woodford counties, the jurisdictions shall be concurrent within said counties and extend as provided in ARTICLE 11 (SECTION- D)(1). Boone, Grant and Kenton counties shall be regarded as one jurisdictional unit. Henderson, Union, and Webster counties shall be regarded as one jurisdictional unit. (2020)

SECTION 3- NEAR STATE BOUNDARY. Section 97

The jurisdiction of lodges near the borders of other states may extend half way to the nearest lodge in such other Grand Lodge jurisdiction provided there be an agreement to that effect between such Neighboring Grand Lodge and this Grand Lodge, and further provided if the petitioner lives in Kentucky he shall have a choice of jurisdiction, except in Pike County, Kentucky and Mingo County, West Virginia. (2001)

SECTION 4- JURISDICTION WAIVED. Section 98a

Waiver of Jurisdiction may be given by any lodge possessing jurisdiction over a candidate for degrees or affiliation, in favor of any other lodge. In such cases, the lodge in whose favor the waiver shall be made may entertain the petition of such candidate as if he had resided within the jurisdiction thereof the required period of time. In all cases where the fee of the lodge granting the waiver of jurisdiction is greater than the fee of the lodge requesting the waiver the candidate shall pay to the lodge which asks the waiver a fee equivalent to the fee he would have been required to pay had he petitioned the lodge which granted the waiver. Immediately after the candidate is elected and initiated, the Secretary of the lodge receiving the waiver shall send the difference in fees to the lodge granting the waiver.

SECTION 5- WAIVER OF JURISDICTION—HOW GRANTED. Section 98b

Waiver of Jurisdiction can only be granted by a lodge

having jurisdiction, and upon request made by a lodge, over its seal, to which the petition for degrees or membership has been presented. The request may be sent by first class mail, electronic mail, or hand delivered. The answer or reply will be sent by similar manner. Before granting the waiver, the application will be referred to a committee of three members of the lodge for inquiry into the character and qualifications of the petitioner mentioned in such request. Such request can only be received at a stated communication and one lunar month must intervene between its reception and ballot thereon. The vote on the waiver shall be by ballot, and if as many as three votes be cast against the waiver the request shall be refused.

Within the state, jurisdiction will be waived automatically 90 days after a request for waiver is sent to the secretary of the lodge possessing jurisdiction unless the lodge possessing jurisdiction denies the waiver and notifies the requesting lodge in writing prior to the 90th day. For just cause the lodge possessing jurisdiction may impose one extension of not more than thirty days with written notification to the requesting lodge prior the 90th day. At the end of such extension the jurisdiction will be waived automatically unless the lodge possessing jurisdiction denies the waiver and notifies the requesting lodge in writing prior to the end of the extension. Automatic waiver of jurisdiction does not apply to requests for waivers to or from other Grand Jurisdictions. (2018)

If a waiver of jurisdiction is granted and the petitioner is subsequently rejected by the requesting Lodge, the jurisdiction shall return to the Lodge for the person as designated in Article 11, Section 1 (D) and a new waiver would be needed before the petitioner could join any other Lodge. (2019)

SECTION 6 - INVADED JURISDICTION. Section 99

A lodge that receives the petition and initiates a candidate, or admits to membership a brother from a jurisdiction not its own, in violation of the provision of ARTICLE 11 (SECTION- D) (1-4), shall forfeit and pay the fees to the lodge which lawfully held jurisdiction, and be subject to having its Charter arrested, or such other penalty as the Grand Lodge shall impose.

SECTION 7 - MOVING FROM JURISDICTION. Section 100

Moving from the jurisdiction of a lodge does not forfeit lodge membership. If he is an officer of a lodge, a brother does not forfeit such office if he is able to attend with reasonable regularity, otherwise he will be subject to ARTICLE 11 (SECTION-B) (5).

(Proposed to Read)

ARTICLE 11(D)- JURISDICTION SECTION 1- GENERAL RULE.

The jurisdiction of every subordinate lodge shall extend to the several boundaries of this Grand Jurisdiction and be concurrent.

SECTION 2- BACKGROUND CHECKS

All petitions for degrees, petitions for affiliation by dual membership (out of state), petitions for affiliation by transfer (out of state) petitions for affiliation by demit, and petitions for restoration (after one year has lapsed since suspension) shall have a background check completed and the results transmitted to the Master and Secretary of the lodge petitioned, prior to the report of the investigation committee being presented. Such background checks shall be completed by The Grand Lodge of Kentucky F. & A.M. and will be of no cost to the subordinate lodge.

Petitions for affiliation by dual membership (in state), petitions for affiliation by transfer (in state), and petitions for restoration (less than one year having lapsed since suspension) shall not need to have a background check completed.

SECTION 3- WAIVER OF JURISDICTION- HOW GRANTED IN KENTUCKY.

Waiver of Jurisdiction may be granted by the Grand Master of The Grand Lodge of Kentucky F.& A.M., following receipt of the background check results, on candidates who fall under the jurisdiction of the Grand Lodge of Kentucky and petition out of state lodges.

SECTION 4- WAIVER OF JURISDICTION- HOW GRANTED OUTSIDE OF KENTUCKY.

Waiver of jurisdiction may only be granted by a Sister Grand Lodge having jurisdiction, and with the results being returned to The Grand Lodge of Kentucky F. & A.M. and these results being forwarded to the subordinate lodge that requested it before they can act on it. No ballot shall be cast on a candidate for whom another Grand Jurisdiction possesses jurisdiction may be conducted until a Waiver of Jurisdiction has been received by The Grand Lodge of Kentucky F. & A.M. and forwarded to the subordinate lodge requesting such.

SECTION 5- INVADED JURISDICTION.

A lodge that receives the petition and initiates a candidate or admits to membership a brother from another Grand Jurisdiction not its own, are in violation of the provision of Article 11(D) (1-5), shall be subject to having its Charter arrested or such other penalty as The Grand Lodge of Kentucky F. & A.M. shall impose.

SECTION 6- MOVING FROM JURISDICTION.

Moving from the jurisdiction of a lodge does not forfeit lodge membership. If he is an officer of a lodge, a brother does not forfeit such office if he is able to attend with reasonable regularity, otherwise he will in subject to Article 11(B)(5).

ARTICLE 14 - CANDIDATES

SECTION 1 – QUALIFICATIONS OF APPLICANT. Section 119

A Candidate for initiation, or affiliation in a Kentucky Lodge shall be a man of the age of eighteen (18) years or more, and of good report. (2008)

(Proposed to Read)

ARTICLE 14 - CANDIDATES

SECTION 1 – QUALIFICATIONS OF APPLICANT. Section 119

A Candidate for initiation, or affiliation in a Kentucky Lodge shall be a man of the age of eighteen (18) years or more, willing to voluntary consent to a background check performed by an accredited firm, and of good report.

ARTICLE 28- LODGES UNDER DISPENSATION

SECTION 2 - HOW TO ESTABLISH A LODGE UNDER DISPENSATION. Section 191

A lodge under dispensation may be established on the petition of not less than 15 Master Masons, residents of the jurisdiction of the proposed new lodge, who shall file with said petition their demits or statements of good standing, certified and sealed by the Secretaries of their lodges, and the consent of every lodge whose jurisdiction would be affected by the new lodge if established. Should the proposed new lodge be located in a city in which there are three or more lodges, the consent of a majority only of said lodges shall be required before a dispensation can be granted for the formation of the new lodge, provided, however when a subordinate lodge reaches a membership of 200, its consent shall not be required for the creation of a new lodge in its jurisdiction. The petitioners shall also

file the certification of the lodge selected by the Grand Master which shall state that the proposed Master and Wardens have been examined audibly in said lodge and found capable of doing the work of the symbolic degrees in a creditable manner. (2001)

ARTICLE 28- LODGES UNDER DISPENSATION SECTION 2 - HOW TO ESTABLISH A LODGE UNDER DISPENSATION. Section 191

A lodge under dispensation may be established on the petition of not less than 15 Master Masons, residents of the jurisdiction of *The Grand Lodge of Kentucky, F. & A.M.*, who shall file with said petition their demits or statements of good standing, certified and sealed by the Secretaries of their lodges, and the consent of every lodge within a tenmile radius of the physical address of the proposed lodge under dispensation, regardless of the number of members of said lodges. The petitioners shall also file the certification of the *Committee on Lodges Under Dispensation* which shall state that the proposed Master and Wardens have been examined audibly in said lodge and found capable of doing the work of the symbolic degrees in a creditable manner. (2001)

ARTICLE 9, SECTION 3 - NUMBER ON EACH.

The Committees on Biography, Necrology and Proceedings of other Grand Lodges shall each consist of only one (1) member; the other Committees shall each consist of three permanent members of the Grand Lodge except as otherwise provided herein. *The Committee on Masonic Education shall consist of no less than three and no more than six permanent members of the Grand Lodge.* The Committees on Masons Helping Masons and Veterans Affairs shall consist of no less than three and no more than ten permanent members of the Grand Lodge except as otherwise provided herein. (2018)

The Grand Master shall appoint the Grand Chaplain, Grand Senior Deacon, Grand Junior Deacon, Grand Marshal, Grand Sword Bearer, Grand Pursuivant, Grand Tiler and Assistant Grand Tiler.

The Grand Secretary shall appoint the Assistant Grand Secretaries, not to exceed more than two (2) during his term of office and these to be subject to the approval of the Grand Lodge, or ad interim, the Grand Master.

The Grand Master and Past Grand Masters shall be addressed as Most Worshipful and all other Elected Grand Officers shall be addressed as Right Worshipful. The Grand Chaplain shall be addressed as Right Reverend and the remaining Appointive Grand Officers as Worshipful. (2000)

- (3) In the event that a qualified candidate from that area is not available or there is no proposed candidate running, that area forfeits selection to the next area.

MASONIC LIBRARY AND MUSEUM ASSOCIATION COVINGTON SCOTTISH RITE
"I Didn't Know That....."

On June 1, 1792, Kentucky split from Virginia, to be admitted to the Union as the 15th state. Freemasonry in Kentucky preceded this date with the Grand Lodge of Virginia forming Lexington #25, chartered November 17, 1788 and Paris #25 chartered on November 25, 1791. After statehood, George Town #46, Frankfort Hiram #57, and Abraham U.D. (Shelbyville) also chartered by the Virginia Grand Lodge, would be the five Lodges that would form the Grand Lodge of Kentucky, the first Grand Lodge west of the Appalachian Mountains. William Murray would be the first Grand Master.

Very quickly, Kentucky Masonry would find itself chartering lodges both in and outside its borders, with Harmony #7, in Natchez, the first lodge held in Mississippi Territory, chartered on October 16, 1801. Natchez was an important partner to Kentucky as goods and merchandise were shipped there to be distributed and resold. William Murray no doubt, had connections in Natchez, as he recommended the chartering of Harmony Lodge and would afterward settle in Natchez, passing away in 1805. Harmony Lodge would surrender the charter on September 3, 1814, but revive itself, with many of the old members securing a new Kentucky charter, as Harmony #33, August 28, 1816, and two years later become Lodge #1, on the Mississippi Grand Lodge Roster with five of the seven Grand Lodge officers, being members of Harmony #33, including Dr. Henry Tooley as Grand Master and Christopher Rankin as Deputy Grand Master.

The first lodge founded in Indiana territory, Vincennes Lodge #15, was instituted by the Grand Lodge of Kentucky on August 13, 1809. Vincennes had been granted a dispensation on August 27, 1807, to form the lodge but had failed to organize.

Indiana Masonic historian Daniel McDonald advises that the G.L. of KY granted the dispensation to form a lodge at Vincennes, "with George Wallace Master, James Adams Senior Warden, and General W. Johnson Junior Warden." On September 1, 1808, General W. Johnson wrote that several circumstances had prevented organization, and as the dispensation had expired, asked that another be issued, which was done, with the same officers as before—in other words, the dispensation was renewed."

Both Vincennes #15, and the future Grand Lodge of Indiana, owes much to Brother General Washington Johnson (Johnston). G. W. Johnson was a member of Abraham Lodge #8, in Louisville, Kentucky, and it was through Abraham #8 that the Vincennes' brothers made a request for their dispensation. Serving as Master of Vincennes on January 18, 1817, Johnson noted for his blandishments, wrote a circular letter "to all Lodges known to exist" to consult on the creation of a Grand Lodge in Indiana. He represented Vincennes Lodge at the Corydon convention in December to form a Grand Lodge of Indiana which would come to fruition with Kentucky native and Charleston, Indiana resident, Alexander Buckler as the first Grand Master, on January 12, 1818. Kentucky, the "Mother Grand Lodge" was the first to extend fraternal recognition. Besides Vincennes Lodge #15, the Grand Lodge of Kentucky would charter five additional Lodges in Indiana to assist in the forming of the Grand Lodge of Indiana, with Vincennes Lodge as #1.

Madison Lodge #21, the second chartered lodge in Mississippi Territory by the G.L. of KY (August 5, 1812) would become the first lodge in Alabama. The city would be later named Huntsville after founder John Hunt, a member of the lodge. In 1812, the lodge reported 31 members, 3 FC and two EA, with Marmaduke Williams-Master, John C. Hamilton -Sr. Warden and Wm Harrison- Jr. Warden. Its Kentucky charter lasted until 1819, with the decision to became Madison #1 under the Grand Lodge of Alabama which was formed 1820. In 1824, Madison #1 and Bethesda #2 consolidated as Helion #1, where it continues to be the birth place of Alabama Freemasonry.

Also in 1819, a group of Masons from Arkansas Post petitioned the Grand Lodge of Kentucky to form Arkansas Lodge U.D. The #59 was assigned sometime in 1820, thus establishing the first lodge in Arkansas, with Robert Johnson as Master. One of the founders was Andrew Scott, then serving as Superior Judge of Arkansas Territory. He was a former Master of Potosi #39, established by the Grand Lodge of Kentucky in Missouri.

In all, Kentucky, the first Grand Lodge west of the Appalachians, would establish eighteen lodges without its borders. The four lodges mentioned above, would be the first in the territory that would later receive statehood, and five others, had no Grand Lodge of their own. Each of these lodges would have their own story to tell, but the all-embracing story is that Kentucky Freemasons significantly influenced the Western Territory. Many of these Kentucky Masons would become leaders in their new communities and states, several reaching objectives as high as Governor.

The seed was sown and the Grand Lodge of Kentucky established lodges, that would grow to form their own Grand Lodge and this early nineteenth century movement would rapidly extend Kentuckians far west, championing the Texas fight for Independence, with many Kentuckians settling there. Author James D, Carter in his history Masonry in Texas lists the lodges that "contributed the major portion of early Texas colonists between 1788 and 1821." Fifty-seven lodges founded by Kentucky's Grand Lodge are recorded.


