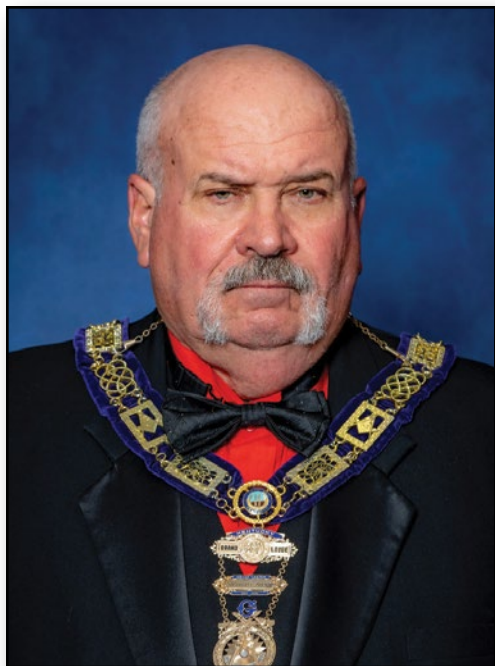

### Dreier Elected New Board Chair of Masonic Homes Kentucky

LOUISVILLE, KY (Dec. 4, 2023) – Masonic Homes Kentucky recently elected Northern Kentucky resident Keith Dreier as new Board chair. He will assume his position in January 2024.

Dreier will oversee the Board, comprised of six elected Grand Lodge officers and 15 elected Kentucky Masons, who provide counsel and direct Masonic's mission and vision. He is past grand master of the Grand Lodge of Kentucky, F.&A.M., and currently serves as grand treasurer.

Dreier has served on the Board for more than 13 years and served on the Executive, Finance/Endowment and Mission Advancement committees. He completed his Masonic degree work from 1975-76 in Missouri. He has been a Kentucky Mason since 1982 and, a member of Trinity Lodge No. 163 and William O. Ware Lodge of Research No. 999.

Dreier retired in 2023 after 47 years of service from Chiquita Brands Inc., in Cincinnati, OH. He held various sales roles including his final position as director of trading North America.

"Masonic Homes Kentucky has been fortunate to have Keith's business and financial acumen on its board for several years, and now he will assume an even broader role as chair," said Chief Executive Officer J Scott Judy. Dreier received his bachelors of science from Murray State University in Murray, KY, with a degree in marketing and was a member of the Lambda-Eta chapter of Lambda Chi Alpha at Murray State.

## Masonic Homes announces new Board Members, honors Harold Armstrong, PGM

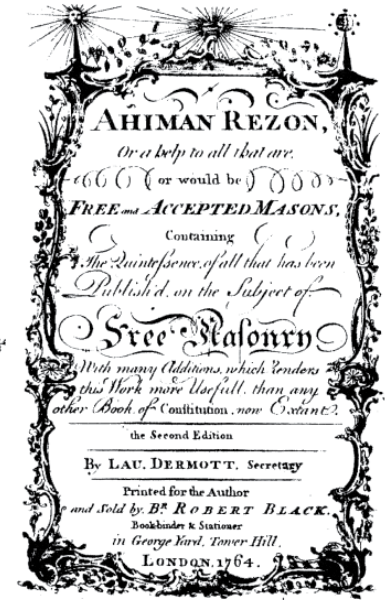
*"I Didn't Know That....."*

After five Kentucky Lodges separated from the Grand Lodge of Virginia, to form the Grand Lodge of Kentucky, they made use of their Mother Grand Lodge's Constitution, the **"Ahiman Rezon or a Help to a Brother"** for Virginia. Kentucky would print their own **"Masonic Constitutions or Illustrations of Masonry"** in 1808. Although many states (Pennsylvania, Virginia, Maryland, North Carolina, South Carolina and Georgia) adopted the name **"Ahiman Rezon,"** for their Constitutions, Kentucky did not. Many of those that did would later drop the title **"Ahiman Rezon"** years after the name was no longer in use in England, due to the forming of the United Grand Lodge of England in 1813.

**"Ahiman Rezon"** was the title assigned to the Book of Constitutions of the **"Grand Lodge of the Ancient Freemasons in England."** and written by Laurence Dermott in 1756. The "Ancients" are believed to be formed by a group of Irish Masons in London, in the mid-eighteenth century, in opposition to the regular Grand Lodge of England innovations including the lack of conferral of the Royal Arch degree, and disregard for the annual installation ceremony. Dermott, Secretary of the group, found it his duty to write the Constitutions for the new Masonic Grand Lodge. The title chosen by Dermott has perplexed Masons ever since it was written.

Many distinguished Masonic scholars have attempted to solve the true definition of the title. Albert Macke attempted to derive it Hebrew. Breaking the word down into syllables, he came to believe, (allowing for corruption of the spelling errors) the meaning was *"will of the selected brethren or laws of men selected to be brethren."* Others of equal stature, defined the corrupted Hebrew words meant *prepared brother; secrets of a prepared brother; brother secretary; will of a selected brother; Royal Builders;* etc. Another interpretation decided that the title wasn't Hebrew at all, but Spanish! Ahiman was said to have the meaning *"Justice or according to law"* and Rezon, meaning *"reason,"* or "there is a full account of the law."

In the **Holy Bible**, Ahiman and Rezon are both being proper names. In the preface of his Constitutions, Dermott mentions he dreamed of meeting four brothers: Shallum, Ahiman, Akhub and Talmon. According to 1 Chronicles 17, Ahiman was a Levite, one of the gatekeepers. Rezon

was a Syrian, and an enemy of King Solomon (see 1 Kings 11:23). Also in his preface, Dermott tends to mock the Anderson's Constitution, and the "Moderns," even though his **"Ahiman Rezon"** is almost a copy of *Anderson's Constitution of 1738* or possibly a copy of the Irish Constitutions of 1751, which was also taken from Anderson's Constitutions of 1738.

Could it be possible that Laurence Dermott thought of 'Ahiman' as representing the true Ancient Freemasonry and 'Rezon' as the 'Moderns' the enemy, making changes to King Solomon's Freemasonry with both under the same Constitution and Ritual? .....*What do you think?*

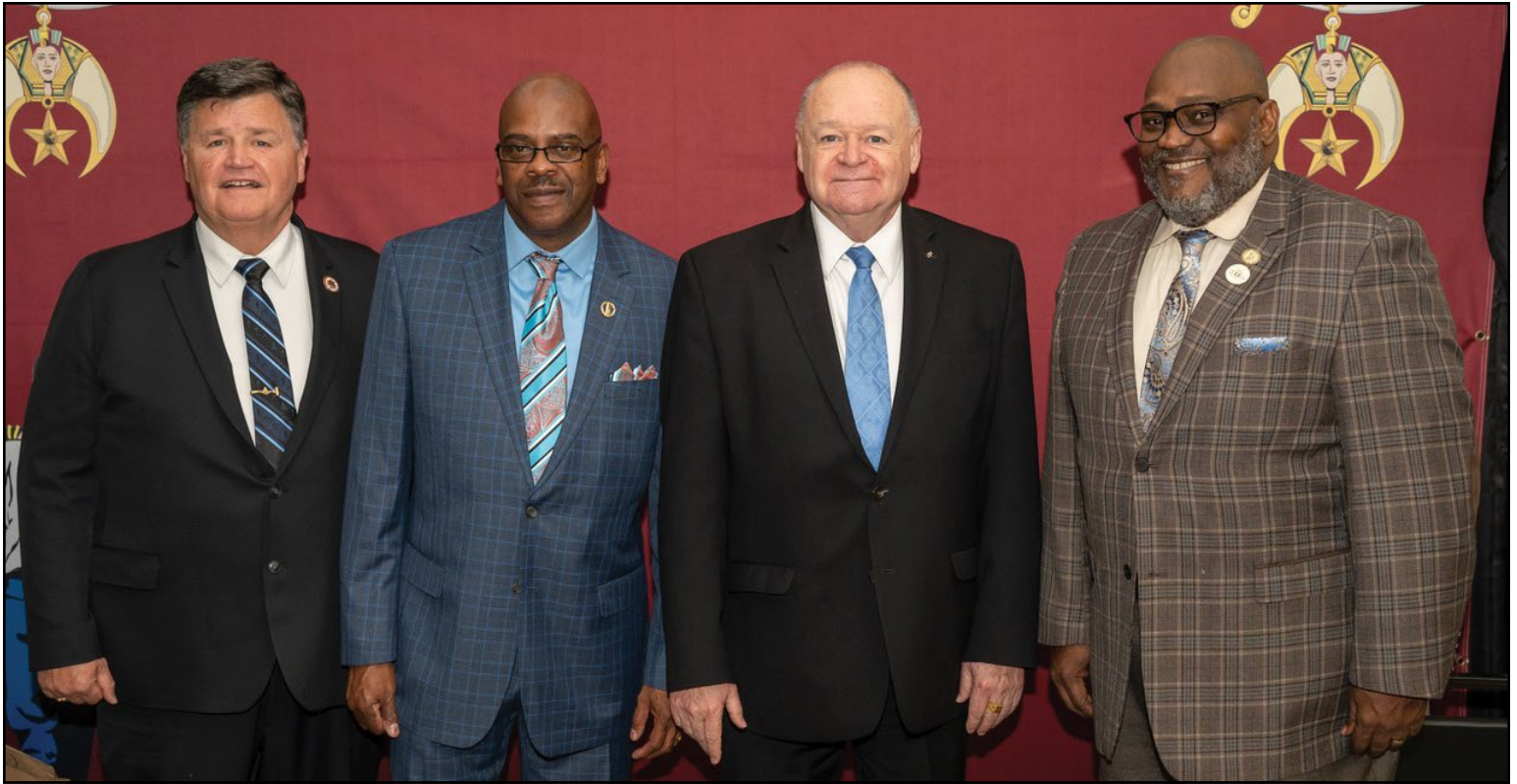

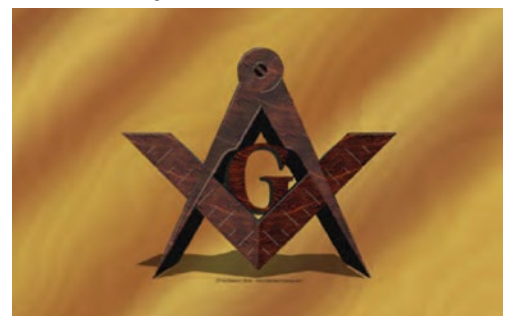

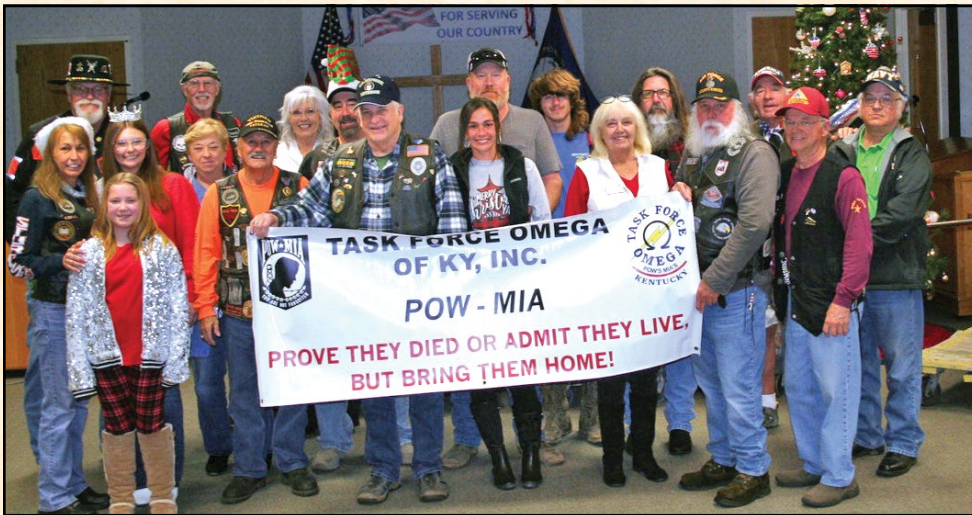
