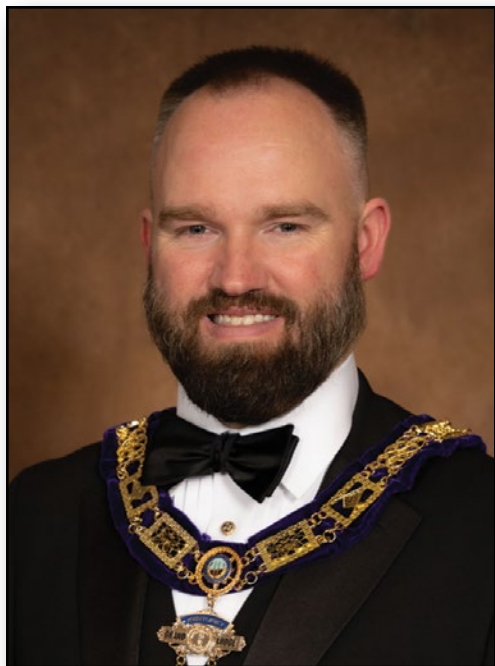

## GRAND MASTER'S MESSAGE

My Brethren,

From time to time, I find myself listening to recordings on YouTube of influential individuals as I travel to and from lodge functions across the Commonwealth. Recently, while driving home one evening, I had the opportunity to listen to a recording of the renowned poet Maya Angelou speaking at a conference nearly thirty years ago. At the event, Angelou shared a story from her childhood, when she lived with her grandmother and disabled uncle in Stamps, Arkansas. Her uncle, Willie, ran a store, and to encourage her to learn her times tables, he would grip her by the back of the neck and hold her close to a hot potbellied stove until she correctly recited her arithmetic. Needless to say, she quickly mastered her "sixes and sevenses."

Years later, after her uncle's passing, Angelou returned to Arkansas for his funeral. At the service, a family friend introduced her to a gentleman named Mr. Bussey who was eager to meet the famous author. Mr. Bussey immediately said to Angelou, "I don't want to shake your hand. I want to hug you." Mr. Bussey explained that he was the only son of a blind mother and that Uncle Willie had employed him at the store during his childhood, teaching him his times tables in the same strict way. According to Mr. Bussey, "Because of your Uncle Willie, I'm who I am today."



During their conversation, Mr. Bussey gave Angelou the name of an attorney in Stamps who could help with the legal matters surrounding her uncle's affairs. When she arrived in the southwest Arkansas town, not far from the Texas border, she expected to meet a black man, but instead, a young white attorney stood and greeted her. "Miss Angelou, I'm delighted to meet you," he said as he introduced himself. He then shared how Mr. Bussey was regarded as the most influential African American in Arkansas, having been the first black mayor of Little Rock, and described him as a noble man. "Because of Mr. Bussey, I'm who I am today," the young white attorney stated. Jokingly, Angelou replied, "Let me sit down first." The young man explained that he, too, was the son of a blind mother, and when he was eleven, Mr. Bussey had taken him under his wing, inspiring in him a love for learning. At the time of the exchange between the young attorney and Mrs. Angelou in Stamps, he was serving in the Arkansas Legislature. To all of this Angelou surmised: that which is important in life is "That which lives after us."

As Freemasons, particularly as Kentucky Freemasons, these words should resonate with us. Anyone who has the pleasure of sitting in the auditorium of the Louisville Scottish Rite Temple needs only to look up to find a similar phrase inscribed above the stage, "What we have done for ourselves alone dies with us. What we have done for others and the world remains and is immortal." These words, penned by Past Grand Commander Albert Pike, encapsulate the commission within our rituals to go forth practicing the teachings contained within the Volume of Sacred Law to all humanity. Do good unto your Brother. Do good unto the non-Mason. Do good unto those who support you, and do good unto those who do not. Our duty as just and upright men extends beyond our Brothers; it is important to remember the admonition we often hear within the walls of our lodges: "Do good unto all!"

Another Past Grand Commander, Past Grand Master of Kentucky, and Past Master of Louisville Lodge No. 400, hailing from the cave country of Edmonson County, once said, "Let everyone who fares forth from the portals of [a Masonic] Temple preach brotherhood, spiritual and educational liberty, high ideals, and righteousness." My Brothers, by living the principles of our Craft every day and positively influencing everyone we meet, we can emulate the example of Uncle Willie. Through our commitment to the teachings of Freemasonry and by living those teachings each and every day, we can leave a legacy that will outlast us for generations.

Was it likely for Uncle Willie, a handicapped black storekeeper in the rural Jim Crow South, to travel the world teaching literature or become the mayor of Arkansas's largest city and capital? Probably not. But through his dedication to providing education to those around him, he helped shape the life of a world-renowned poet who would later receive the Presidential Medal of Freedom and become only the second person to recite a poem at a United States presidential inauguration. He instilled a love of learning in the heart of a young boy who would go on to become the Mayor of Little Rock, and in turn, that same boy helped guide another young man who would later serve in the state legislature. Can any of us change the world overnight? No. But through our steadfast commitment to the principles and tenets of Freemasonry, and by spreading the light of education, with time, patience, and perseverance, we shall accomplish all things!

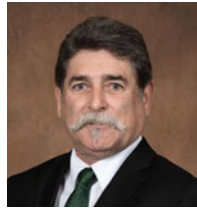

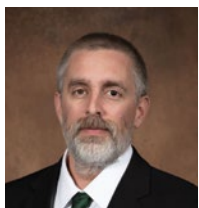

## GRAND HISTORIAN'S NOTES

My Brothers,

This month I have chosen to share with you an article written by Worshipful Brother David Paul, Past Master of Buford Landmark No. 41 and a member of the Grand Lodge Committee on Masonic Scholars, concerning the life and legacy of Brother Robert Crittenden. I hope you find the following both enjoyable and informative:

The subject of this article was discovered while touring the Grand Lodge of Arkansas Museum. Right Worshipful Andy Miller, Grand Librarian of Arkansas, handed me the book, *They Made a Difference: Arkansas' Freemasons*. While thumbing through the book, a section referencing Versailles, Kentucky immediately caught my eye. Did you know a Kentucky Mason is considered the First Great Statesman of Arkansas? He assisted in establishing the first Lodge in the Arkansas Territory, which was chartered by the Grand Lodge of Kentucky, and would hire a young Albert Pike as editor of the local newspaper.

Robert Crittenden was born on January 01, 1797 near Versailles, Kentucky, and would serve as a Captain during the Seminole War (1817-1818). After the war, he studied law with his brother, John, and was admitted to the Kentucky Bar at the age of 21. His father, John Crittenden, was a Major during the Revolutionary War and an original member of the Virginia Society of Cincinnatus. Robert's older brother, John Jordan Crittenden, would become

the 17th Governor of Kentucky, U.S. Senator, and U.S. Attorney General. Another older brother, Henry Crittenden, had a son, Thomas T. Crittenden, who would become the 24th Governor of Missouri. All the Crittendens were members of the Fraternity.

In the 1818 Proceedings of the Grand Lodge of Kentucky, Robert Crittenden and brother Henry were listed as Master Masons in Landmark Lodge No. 41, along with brother John as a Master Mason in Lexington Lodge No. 1.



On July 4, 1819, by an act of Congress, the Arkansas Territory was created. President James Monroe, a Mason, recognized Robert's gifts and appointed him to be the first Territorial Secretary at Arkansas Post, the temporary capital. It did not take Robert long to declare Arkansas a territory of the second class, which allowed the establishment of its own legislature and judiciary. He appointed an officer for the counties and organized the local and central government of the Territory. He would put in motion the eventual relocation of the state capital to Little Rock.

On August 28, 1820, Robert would assist in establishing the first Masonic Lodge, Arkansas Post Lodge No. 59, that would later be renamed Washington Lodge No. 1, at the establishment of the Grand Lodge of Arkansas. He donated the land and \$100 for the construction of the building, which was the first building in the territory to be used exclusively as a Masonic Hall. Robert would serve as the first Junior Warden of this lodge.

As he organized the government, he was confronted with many difficulties: no roads, no money, and only two post offices in the entire Territory. He successfully used his influence in urging the relocation of the government to Little Rock, which was situated in a more central part of the Territory along the Arkansas River.

For ten years, Brother Crittenden faithfully served the Territory as Secretary, also acting as Governor much of the time. In 1829, he retired from office and began practicing law in Little Rock. A brilliant lawyer, his fame extended far beyond the borders of the fledgling Territory.

In 1830, he founded the *Arkansas Advocate* and recruited a young Albert Pike to serve as its editor. At that time, Pike was a young educator, teaching at a country school in Pope County. Brother Crittenden recognized the talent of the young Pike and secured him a place at once as editor of the *Advocate*. Albert Pike later bought the newspaper from Brother Crittenden.

On December 18, 1834, while arguing a case before the United States District Court at Vicksburg, Mississippi, Brother Crittenden suddenly fell ill after completing an eloquent oration that lasted nearly seven hours. While attempting to rise, he staggered and fell to the floor of the court. He was carried out of the courtroom to his hotel where he eventually died at the early age of 37. Pike later wrote of Brother Crittenden, "He was a man of fine prescience...of unmistakable intellect and genius, frank and gentile, a thoroughly well-bred Kentucky gentleman and conscious of his own greatness."

### THE ELEUSINIAN MYSTERIES: A JOURNEY DOWN THE SACRED WAY

#### Part II of II

The 16th of Boedromion, the second day of the mysteries, was known as the Elasis. The participants would each take a sacrificial pig and make the journey by carriage to the sea with their mystagogoi, where they would ceremonially wash themselves and the pig in the waters, which were considered immaculate and purifying. They would then return to Athens where each candidate would sacrifice his or her pig by themselves.

The third day of the mysteries, the 17th of Boedromion, was known as the Day of Sacrifices. The Archon-Basileus, in the presence of representatives from other cities and of the Athenians, solemnly offered an official sacrifice to Demeter and Persephone in the Eleusinion and offered prayer on behalf of the people of Athens. The representatives from other locations performed the same ritual for their citizens.

The fourth day of the mysteries, the 18th of Boedromion, was called Epidauria or Asklepieia, in honor of the god of medicine, Asklepios. There was a local tradition that Asklepios was late coming from his Sanctuary in Epidavros to the purification rituals and sacrifices at Athens. Therefore, on this day, these rituals were repeated. This offered an opportunity for those arriving late to complete these ceremonies. This was also a day of rest for those who had already completed the rituals.

The fifth day of the mysteries, the 19th of Boedromion, was termed Pompe. This day was the final day of the rites which involved Athens. This is the day of the great procession and return to Eleusis. The initiates and their mentors gathered at the Dipylon Gate at the head of the Sacred Way. This area was known as the Kerameikos, the potter's quarter of the city, and where ceramics were produced. This location was also an important cemetery with many funerary monuments along the way. This is a fitting start to a journey that may represent death or Persephone's abduction to the underworld and Demeter's sad journey in search of her. The priests and priestesses removed the Holy Objects from the Eleusinion and took their place at the head of the procession. The Holy Objects were replaced in the urns or kistai, which were carried on the heads of the priestesses. A statue of the god Iacchos, possibly a version of Bacchus, or Dionysus, the god of wine and festivities was placed at the head of the procession. This large cohort then began the slow 14-mile journey to Eleusis on foot, passing through the cemeteries and shrines, including the Shrine of Aphrodite, which were situated next to the Sacred Way. As they approached Eleusis, they had to cross a bridge over the Kephisos river. As they crossed, men would direct insults at the most prominent participants to humble them prior to the solemn ceremonies to follow in the coming days.

The procession finally reached its destination at the Sanctuary of Demeter in Eleusis. Upon arrival, the priestesses with the Holy Objects danced around the Well of the Maidens, beside which Demeter had rested during her search. The participants then sought shelter and rest at hostels and inns near the Sanctuary at the conclusion of this fantastic and strenuous journey.

The sixth day, the 20th of Boedromion, was a day of fasting and purification. It was observed to memorialize the fasting and sadness of

Demeter after the abduction of Persephone and was considered essential for the purification of the body prior to experiencing the mysteries. They also abstained from drinking wine in commemoration of that moment when Demeter refused the wine from Metaneira. The fasting ended with drinking the kykeon, a mysterious drink based on Demeter's instructions of meal, water, and mint, and possibly infused with hallucinogens. These mysteries were designed to be transformative and the induction of alterations in consciousness may have contributed to this effort, although this assertion is controversial. During the night and over the next two days the ceremonies occurred in earnest.

As the proceedings were kept in the strictest secrecy, faced with the penalty of death, we do not know with certainty the events which occurred for the remainder of the festival. We do know from the scattered writings available and from archaeological evidence that the ceremonies included three features: dromena (that which was enacted), deiknymena (that which is shown), and legomena (that which is spoken).

The dromena almost certainly consisted of plays or allegories representing the saga of Demeter, Persephone, and Hades. We know that once the candidates entered the Greater and Lesser Propylaea, or gateways, they were in the presence of the terrifying Plutonion, the gateway to hell. It was believed that the caves behind the Plutonion temple were used by Hades and Persephone to traverse between the earth and the underworld. It is logical to assume that the abduction of Persephone was reenacted here. Venturing farther into the sanctuary, the candidates were able to lay eyes upon the magnificent Telesterion, the heart of the sanctuary, and where most of the allegories were exemplified, and the most esoteric knowledge was revealed.

The Telesterion was a temple that was in use for centuries, but then destroyed by the Persians in 480 BC, and then reconstructed in a form large enough to hold thousands of people. The remains visible today are from this reconstruction. Inside the Telesterion was a small rectangular building called the Anaktoron, the Holy of Holies of this temple. It was here that the sacred objects were kept and eventually revealed by the Heirophant in a brilliant flash of light. The identities of the holy objects of the Deiknymena, or objects which were shown, are, to this day, unknown. There are multiple extant sculptures and reliefs which contain the repeating pattern of wheat (symbol of Demeter), rosette (symbol of the poppy which grew from the tears of Demeter), and urn (which contained the holy objects). Their significance to the holy objects is not clear.

The legomena, or things that were spoken, can be deduced to be explanatory lectures, instruction, and prayers to complete the transformation of the initiates. This tradition can be seen in the modern lectures which accompany our Masonic initiations or the sermons or homilies which accompany modern religious observances.

The ninth day of the ceremonies was the long slow return of the participants back to Athens or to their final destinations. This was not an organized procession like the pompe from Athens to Eleusis. They were

not obliged to return to Eleusis to worship or to join religious groups with other initiates. The citizens were free to return to their mundane lives, their souls and psyches transformed from profane to initiated. The Athenian officials gathered at the Eleusinion at the base of the Acropolis to hear the report of the celebrations and to learn from any negative occurrences. And with this somewhat anti-climactic administrative function, the ten days of the Eleusinian Mysteries was finished.

Our understanding of the Eleusinian experience can best be increased by the words of those who had received the initiation. Plutarch, the historian and priest at Delphi, stated that when a candidate has “beheld the great light, as when the anaktoron opens, changes his behavior and falls silent and wonders.” (De profectu in virtute 81). Sophocles stated that “Thrice blessed of mortals are those who go to Hades after beholding these rites. To them alone, it is given to live there, to others everything there is evil (Plutarch, How to Study Poetry, 21f). And the great philosopher Aristotle said, “Initiates do not need to understand anything; rather they undergo an experience and a disposition – become, that is, deserving.” (Aristotle, Synesius, Dio, 10).

Our knowledge of the Eleusinian mysteries will always be incomplete because the priests, priestesses, officers, and initiates took their vow of secrecy seriously. The ancient Greeks deemed these secrets so important that they guarded them with their lives. These secrets could not be trivial

and elicit this response. Ancient Greeks had no podcasts, social media posts, websites, or periodicals with which they could easily violate their obligations and reveal their secrets unlawfully. We unfortunately are too easily tempted to propagate our proceedings despite our own vows of secrecy as Masons, and in the process, profane our holy Rite. How much do we truly value our Masonic experience?

The events at Eleusis changed the initiates forever. Their journey from Athens to Eleusis was both an intensely physical and an intensely spiritual journey. Every person of consequence in Athens and the Greek world desired to participate in these rites and become true initiates. An initiation is intended to be permanently transformative. It is not merely an “induction ceremony” or a time to welcome and haze new members. As we examine ourselves and our lodges, are we rising to the initiatic standards set by our ancient brethren? Are the influencers and visionaries of our society seeking initiation at OUR doors?

A true initiatic experience changes a person by placing them in the presence of something larger than himself, opening the door for the initiate to commune with the divine and become the best version of themselves. We, as Freemasons, owe it to our candidates to perform the work to the absolute best of our abilities with the utmost reverence and awe, just as they did centuries ago in that small community 14 miles from Athens.

### GOAL SETTING: ANALYZING YOUR GOALS

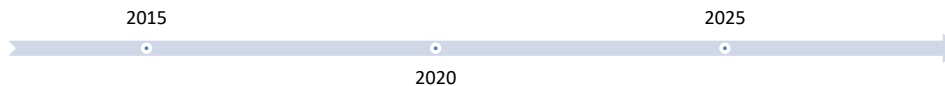
In April, our goal setting article dealt with having discussions and finding areas for change. Once your lodge has found these potential goals, it is important to analyze them to see if they are achievable. One such area that affects many lodges is membership. It is easy to see the urgency of a need to increase membership and end up setting a goal that is not achievable and will end up discouraging the members from trying to improve in the future.

Here is an example of a goal that sounds good, but is not reasonable:

“We are going to double our membership this year.” Let’s determine if it is realistic. We can use simple math to explore the feasibility of this potential goal: Let’s say Lodge A has 100 members. Lodge A sets a goal to double membership by the end of year.  $100 \text{ members} + 100 \text{ new members} = 200 \text{ members}$ . “If each member brings in 1 new member the goal is achieved.”

This sounds good, but what if only 20% of members attend lodge A. So, 20 members are responsible for increasing membership by 100. Each active member would have to bring in 5 members, and that is not counting that it is illegal to ask people to join. That is not counting the possibility that each potential new member might not pass the ballot box. Not counting deaths, NPDs. The goal is NOT realistic.

So how do we set a *realistic* goal? You have to do your homework. Gather relevant information from your secretary. Use current information and make a chart.



How many members were initiated EA? FC? MM? How many were suspended NPD? How many died? How many dual members? How many members moved membership? How many members each year 2015 – 2025? How many 25, 40, 50+ members?

You may need more than one chart, but once you have gathered the data, your lodge can begin to discuss the reasons the membership has dropped off, and what the brothers can do about it. A more reasonable goal for Lodge A might be to reach out to current members to see why they are not attending, and what could be done to help this situation or to become involved in more events that reach out and establish a presence in the community.

I want to say this again. I’m not telling you how to run your lodge. These are ideas to improve your lodge. Every lodge has a different path, and when you do the research with the treasurer’s and secretary’s records over the last 10 years, you will see the path your lodge is on. If there is anything West KY Consistory can do to help your lodge, please reach out to us.
